DISCUSS AND REVIEW THE RESULTS OF THE TRACY TRANSIT STATION CIVIC ART PROJECTS

DISCUSSION

The Civic Art Subcommittee met on Thursday, December 3rd to review the Final Designs. Five of Six projects were approved as submitted. The sixth, People and Places of Tracy by Gordon Huether received partial approval. Gallery Supervisor Wilson relayed feedback to all of the Artists, and presented updated support materials for Mr. Huether's project to Subcommittee members on Friday, Saturday 19th. Mr. Huether's Final Design was subsequently approved. All Artists are now under contract and working on their projects in anticipation of the opening of the Tracy Transit Station in February. It is foreseen at this time that only Pauline Tolman's Bus Shelters project will need extension beyond February.

At the TAC Meeting on Tuesday, December 8th, Staff presented correspondence from Sandra Mollon who served the Civic Art Subcommittee's TTS Project Committee who was responsible for the formal review process of the proposals for Civic Art at the new station. Ms. Mollon's letter was originally submitted to City Council via the City Clerk on October 5th, 2009, but a clerical error prevented forward to the Arts Commission. She then resubmitted the letter to Staff in time for the December meeting.

Ms. Mollon, in response to the City Council review of the TAC recommendations presented on September 15th, 2009, voiced her support of the review process and the efforts of Staff and the Civic Art Subcommittee. Ms. Mollon cited serious concern and dissatisfaction with the comments made by Chair Rothschild. She felt that Chair Rothschild's comments ultimately damaged the efforts of the Civic Art Subcommittee and the goals of the Civic Art Program. In closing she urged Council to continue to support civic art in our community and value the work of the Subcommittee in the future.

Chair Rothschild requested an agenda item for the meeting in January to discuss these issues.
