- 3. ITEMS FROM THE AUDIENCE: Larry Gamino a representative from Westside Pioneers addressed the Commission about a mural the Landmark committee was planning for the Centennial Celebration. The idea came from the City of Livermore which has several murals depicting the City's history. Mr. Gamino expressed his interest and met with the Engineering Department. Since there are so many hurdles to overcome to place the mural on a city building, Mr. Gamino stated the committee is now pursuing a private location. Commissioner Howard suggested Mr. Gamino meet with staff to discuss how the Civic Art Plan may help with this project. Commissioner Silveira suggested a special meeting if necessary once staff has met with Mr. Gamino.

- 6. **NEW BUSINESS**:
  - a. Review and Discuss 2009-2010/2010-2011 Tracy Arts Commission Budgets:
    GS Wilson gave a brief overview of the 2009-2010/2010-2011 budgets. From a historical perspective the allocations for the Multi-Cultural Festival and Music in the Park

have decreased. The exception is the Civic Art Program. This program has increased due to the investment in the City's collection and the expense to maintain the collection. Budgets for the Multi-Cultural Festival and Music in the Park have been part of the discretionary spending cuts.

The Tracy Arts Commission has approximately \$2,343 in the TAC checking account and the Tracy Friends for Parks Recreation and Community Services Foundation combined. If the funds from these accounts are not utilized, Music in the Park will only have four concerts during FY 2010-11. Staff has recommends utilizing the balance in these accounts to cover the cost of sound technicians and to offset the cost of hospitality to performers for the 2010 Music in the Park Series.

Various Commissioners inquired about fundraising and partnerships to offset some of the costs for the Multi-Cultural Festival and Music in the Park. Commissioner Sangha asked if Commissioners can solicit donations. GS Wilson stressed that Commissioners are not to solicit donations.

Currently the City has a Communication/Marketing Strategic Team which provides feedback for all requests for sponsorships from staff or the various departments. GS Wilson stated the City is trying to identify the needs for support. The Commission will need to identify their type of support needed for their programs. For example, the Commission may identify hospitality and marketing as a need for sponsorships. Staff would need to meet with a potential sponsor and then take the request to the Communication/Marketing Strategic Team.

TTS Haskett explained the Commission is not guaranteed funds for their programs. GS Wilson explained the Commission needs to decide how large they want their events and length of the event.

Commissioner Rothschild would like to see the Music in the Park concerts increase as does Commissioner Jones.

The Commission noted that the Multi-Cultural Festival was successful when it was held at Lincoln Park instead of The Grand Theatre. The park gave the festival more visibility. Commissioner Silveira saw a decline of vendors due to the increase in fees and the location change.

A motion was made to use the \$2,343 from the TAC checking account and the Tracy Friends for Parks Recreation and Community Services Foundation account for the 2010 Music in the Park and to allow an amount to keep the account active.

b. Review and Discuss Consideration of Visual Arts at the Music in the Park Series: Staff was asked to indentify issues and provide recommendation to the Commission for discussion and consideration of adding a visual arts component to the Music in the Park concert series. GS Wilson stressed to the Commission that there are several issues to consider since the event is outdoors. For example there are risk management issues, liability and lack of display equipment to name a few. Commissioner Rothschild likes the idea but feels this may have to be done near the end of the season.

Commissioner Hays clarified his vision for this event. He is envisioning 10x10 tent space be allocated to vendors. Commissioner Hays would like to look at this event for the future. GS Wilson stressed the Commission can enhance events but can not create new special events. GS Wilson also stated there would need to be a process for participation.

Commissioner Sangha felt this might be a good addition to the Multi-Cultural Festival. Commissioner Jones agreed.

Staff recommends that no visual arts component be added to the Music in the Park this year. The Commission agreed that they do not have the ability to provide the visual arts component at the 2010 Music in the Park series.

#### 7. OLD BUSINESS:

a. Review and Confirm Talent, Dates and Expense for the 2010 Music in the Park
Series: TTS Haskett informed the Commission he has verbal confirmations for the
Music in the Park series. He was able to secure the Commission's first choice of
performers for each concert. TTS Haskett explained the cost for the event and stressed
the funds from the TAC checking account and the Tracy Friends for Parks, Recreation
and Community Services Foundation account will help offset the costs.

A motion was made to accept the talent, dates and expenses as identified for the 2010 Music in the Park series.
