3. ITEMS FROM THE AUDIENCE:

- 4. 2011-2012 CIVIC ART PROGRAM GOALS & BUDGET RECOMMENDATIONS: GS Wilson distributed Civic Art Program Project Worksheet that tracks recent and current projects. The worksheet documents Program Goals. Also distributed was the Staff recommended FY 2011/2012 Civic Art Program Budget in the amount of \$3,000. Commissioners discussed the anticipated Program needs and agreed to forward this recommendation to the Budget Subcommittee for their consideration in preparation of the FY 2011-2012 TAC Budget recommendations.
- 5. **AQUATICS CENTER DESIGN REVIEW & DISCUSSION:** GS Wilson presented a video illustrating the master architectural and conceptual design for the new Aquatic Center in development. Commissioners identified and prioritized a list of recommendations fro civic art components and considerations that will be forwarded to the AC Design Team.

Recommendations are: 1. Entry Fountain and Entrance Courtyard; 2. Bridges; 3. Retention Walls/Seating throughout Center; 4. Signage/Wayfinding; 5. Other Seating/Benches; 6. Volley Ball Court-Net Posts.

In general, there is a strong preference to a universal approach to addressing the Center as opposed to individual, smaller projects. Bridges and retention walls are an attractive and interesting placeholder for a project (stamped concrete, tiles, mosaic, etc.) that would provide a significant impact to the overall design and experience for visitors/users. In addition, Commissioners inquired abut the lighting plot/design of the center with the idea that having a Lighting Designer/Artist create a custom light-based project to add a highly unique feature to the facility. If considered, this would also have a high priority in the recommendations.

In discussing the potential cost-traders and savings, there were several questions about construction and finish materials including concrete, tiles, tree grates, barriers, planters, etc. This is particularly important to a discussion regarding a more universal (wide-application) approach to adding designed or fine art components. There was also a question as to how the wave rider barrier would be phased into the construction.

6. **CIVIC ART PLAN 2011 REVISE UPDATE:** GS Wilson briefed the Subcommittee on the current status of the ongoing revision to the Civic Art Plan. Copies of the current draft were provided and a meeting was scheduled for February 10, 2011, at 11:00 a.m. to continue discussion and edits in preparation to send the revised Civic Art Plan to City Council by mid-year.

The technical review will begin on March 15, 2011. City Council adoption is scheduled for June 7, 2011.

GS Wilson explained to the subcommittee that the Re-Granting program was a City Council directive but has been suspended due to budget cuts. The response to the program was small and may be looked at in the future. The subcommittee would like to keep the re-granting program as a line item with no allocation.
