1. CALL TO ORDER: Chairman Silveira called the meeting to order at 7:01 p.m.

3. ITEMS FROM THE AUDIENCE:

4. SPEAKER'S BUREAU PRESENTATION: Overview on City of Tracy Business Friendly Efforts: Director Andrew Malik from the Department of Development & Engineering Services gave a brief presentation of the City of Tracy's Business Friendly Efforts. His presentation included a PowerPoint. Mr. Malik shared the seven Business Partnership Principles which are 1) Prioritize Economic Development Efforts; 2) Save Businesses Money; 3) Save Businesses Time; 4) Provide Regulatory Guidance; 5) Make Information Accessible; 6) Provide an Outstanding Quality of Life and 7) Communicate with the Community.

Commissioner Jones asked if there were any plans for Trader Joes or Whole Foods and the long-term horizon for these stores to come to Tracy. At this time these stores are not coming to Tracy.

Commissioner Silveira asked about higher education. The Learning Center will move to the Chrisman site.

There was a question as to whether the City is courting specific companies to come to Tracy. The Northeast Industrial Area has numerous manufacturing companies locating in the area.

The Commission wanted to know what was being done to attract businesses and people to downtown. There are plans for the downtown plaza. There was also a question regarding crime and where it is specifically coming from. According to the crime statistics, violent crime is down 12%, property crime is down 16%.

Commissioner Zolfaghar thought the presentation was wonderful but wanted to know if someone asks why they should bring their business to Tracy what the response is from City staff. Director Malik informed the Commission that sometimes staff does everything possible to attract a business and another City or State may just have more incentives. So there is competition within the industry.

Commissioner Silveira has some concerns with the Air Soft site located so close to the fields at the Holly Sugar site. It is a lease for 50 acres and still has to go before City Council for approval. Citizens will be able to address City Council when the item is presented.

The Commission enjoyed the presentation and thanked Director Malik for the information.

Approve Budget Subcommittee's Recommendation for FY 201/2012 Budget Request to Staff for a total of \$20,200: On January 27, 2011, the budget subcommittee met to discuss the FY 2011/2012 budget proposal and recommended allocations to the Civic Art, Music in the Park, Multi-Cultural Event and Administrative budgets. Commissioner Fuller explained to the Commission that the subcommittee took a realistic approach. In keeping with past years, the subcommittee targeted \$2,500 as their fundraising goal. Each Commissioner would be responsible for raising \$348. Commissioner Zolfaghar reiterated that by fundraising it shows the Commissions commitment to these programs.

Commissioner Howard asked if the subcommittee discussed ways to fundraise the \$2,500. That was tabled for another meeting. Commissioners Sangha and Jones also support fundraising.

Commissioner Howard asked where the money is coming from for the talent. In the past, talent has been paid for and volunteers have also performed. She also asked if there was any discussion on what to do with the extra funds if the Commission exceeded their fundraising goal. The Commission could decide where to spend those funds at a later date.

GS Wilson informed the Commission that the subcommittee was sensitive to the shared responsibility of fundraising and did not want to create fundraising goal too overwhelming.

DISCUSSION

On Thursday March 3, 2011 the Event Subcommittee meet to discuss the Emerging Artist program as it is part of the Music in the Park program.

The Subcommittee voted to keep the program and Commissioner Silveira and Commissioner Sangha agreed to head up the audition panel.

Emerging Artist is a young artist under the age of 18 that sings the National Anthem prior to the concert at the Music in the Park series. The Tracy Arts Commission conducts auditions for the youths to sing a'cappella and then selects a singer for each of the summer concerts. The typical age ranges from 10 to 18 years.
