#### 6. OLD BUSINESS:

**REVIEW AND DISCUSS AND ACCEPT DONOR FORM, SCRIPT, AND RACK CARD FOR FUNDRAISING:** GS Wilson informed the Commission there will be an initial printing of 1000 rack cards for their use. The concept of the tree design was to represent cultural and growth with the Music in the Park series. The Commission requested the yellow color block be changed to green. Commissioner Jones motioned to approve the rack card and Commissioner Howard seconded the motion. Motion carried.

Upon review of the script Commissioner Howard still had concerns regarding the donation policy. Commissioner Howard feels it will be difficult to ask for donations without being able to give the donor something in return.

The fundraising goal for the Commission is \$2500. The Commission can continue fundraising even if the goal is met. Commissioners wanted to know how donors would be recognized. The Commission seemed to be in agreement that a certificate would be a nice way to acknowledge the donor. At this time staff has not designed the certificate. The donors will also be listed inside one of the poster boxes at the theatre.

GS Wilson stated that the script was written to be helpful for novices in fundraising. This will be a useful tool when Commissioners begin their fundraising efforts. GS Wilson also passed around a sample of the donor form completely filled out for Commissioners.

Commissioners can now begin the process of fundraising for their events. Donations will need to be turned into the box office for deposit into the designated account.

REVIEW AND DISCUSS CONCESSION SALES FUNDRAISER AT MUSIC IN THE PARK SERIES: TTS Haskett informed the Commission that concessions would be available for them to sell and use as part of their fundraising efforts at each of the stand alone Music in the Park Concerts. Profits would be minus expenses. At least 2 Commissioners must be present at the booth at all times. If the Commission is unable to do so, TTS Haskett will have staff manage concessions, but the profits will go towards the Grand's concession revenue and not the Commission's fundraising goal. The Commission agreed they would like to sell concessions at the stand alone Music in the Park Concerts. Two Commissioners must be present.

## **DISCUSSION**

The Civic Art subcommittee assits staff with the implementation of the 2003 approved Civic Art Plan. Commissioners will assist on recommendations on future and continuing projects, the on-going maintenance of the current public art and budget.
