The Special Events Subcommittee presented their preliminary recommendations creating an outline of the Festival. Subcommittee voiced a focus to create an interactive, inclusive, and annual event for local businesses, non-profits, and the community-at-large. The actual date is to be determined but recommended at the close of the summer concert series in July or August.

CAM Wilson noted the two important items were addressed by the Subcommittee: 1) an understanding of who should be an invited collaborative partner, while identifying who would be likely to participate; and 2) seeking additional levels of participation from the community (groups and individuals) through the creation of a Vendor Village, whereby non-invited participants could be part of the Festival for a fee.

The Subcommittee explained the recommendations were believed to be achievable in the first year, and then building participation and features as an annual event forward. Commissioner Silveira noted these recommendations are a "living document" that will change as planning and resources develop. Chair McClain suggested the creation of a poster contest with local K-12 schools. Additional discussion included the participation of the West Side Pioneers/Tracy Historical Museum, the Chinese Community, recruitment and communication tools to increase participation in the event, and the event beginning and ending times.

APPOINTMENT OF COMMISSIONERS TO THE FOLLOWING SUBCOMMITTEES: BUDGET, CIVIC ART, SPECIAL EVENTS AND RE-GRANTING

DISCUSSION

Tracy Arts Commissioners serve one-year terms on Subcommittees. Terms begin in January and commence in December annually. Subcommittees work with staff to schedule meetings as needed.

Budget Subcommittee:

The Budget Subcommittee provides input to staff for the upcoming budget process coinciding with the fiscal year running from July to June. Two Commissioners will serve a one-year term.

Civic Art Subcommittee:

The Civic Art Subcommittee works with staff to identify priority projects for civic art, applicable capital improvement projects for artistic enhancement, evaluates, artist concepts and proposals, and served as ambassadors to the community-at-large regarding the Civic Art Program. The Subcommittee forms larger project teams as needed with community members and technical experts as projects demand. Three Commissions will serve a one-year term.

Special Events Subcommittee:

The Special Events Subcommittee works with staff to develop the annual Music in the Park summer concert series and selects Emerging Artists. In addition, this Subcommittee develops multi-cultural programming.

<u>Music in the Park:</u> The Tracy Arts Commission has presented Music in the Park for over a decade. 2014 will be the 14th season. The concerts are typically held in Lincoln Park across six to eight consecutive Thursdays in June and July. Each week a different genre is featured. The concerts begin at 7:00 PM and last approximately two hours each. Talent fees range between \$1,000 and \$2,000 per performance.

The Subcommittee meets several times with staff to review talent and make recommendations on the preferred choice of performers and genre each summer. The recommendations are presented to the Commission by April for review and approval. Staff secures the performers and schedules the concerts.

<u>Emerging Artists:</u> Emerging Artists are young performers under the age of 18 who are invited to sing the National Anthem prior to each summer concert. The Tracy Arts Commission conducts a cappella auditions for youth in the early spring and staff schedules the preferred artists.

<u>Multi Cultural Festival:</u> The Tracy Arts Commission has offered past Multi Cultural Festivals at both Lincoln Park and the Grand Theatre Center for the Arts. The Commission is currently developing a new version of this event celebrating the arts and culture in Tracy including educational and interactive components, as well as community collaborations.

Three Commissioners will serve a one-year term.

Re-Granting Subcommittee:

The Re-Granting Subcommittee evaluates community performers for grants and technical support awards. While grant awards were eliminated with budgets cuts in 2010, technical support has been provided as community groups are presented in the Presenting Season at the Grand Theatre Center for the Arts. The Tracy Arts Commission reviews and approves these recommendations as needed. Two Commissioners will serve a one-year term.
