6. CONTINUE DISCUSSION OF THE TRACY ARTS AND CULTURAL FESTIVAL AND FUNDRAISING GOALS

ACTION The Special Events Subcommittee reported their recommendations to the Commission for discussion. SES recommendations are to invite several community groups to collaborate in the Festival, occupying six booths at the

event: 1. Tracy Friends of the Library in conjunction with a representative organization from Mountain House to provide a literary component, 2. Tracy Sister City Association representing youth exchange programs to Japan, 3. Tracy Animal Shelter with an adoption and art contest component, 4. Tracy Historical Museum – West Side Pioneers with a presentation and display addressing the labor history of the City, 5. Tracy United to Make a Difference with a community service component, 6. Tracy Camera Club and Tracy Art League to provide a visual arts exhibit. In addition the SES voiced support of a martial arts component but no organization was identified, as well as the popularity of having the Tracy Police and Fire Department safety vehicles at the event.

Commissioners responded that the SES recommendations were not diverse enough in representing the cultural diversity of the City, which was a goal of the Festival. Commissioners discussed that while the Library organizations, Tracy Animal Shelter and Tracy United to Make a Difference are important community organizations, perhaps they are not best suited to the immediate goals of the Festival this year. Commissioners agreed to make an effort to diversify the event and contact additional potential collaborators including the Tracy African-American Association, Southside Community Organization, Tracy Indian Women's Association and the Asian-American Association in Mountain House. Commissioners agreed to report at the meeting in June, continue discussion and finalize their list of collaborators to invite to the Festival.

Discussion pertaining to the three headlining performing acts followed with Commissioners voicing that they would prefer a Latin Band, high energy dance act, and a popular performer from a past Music in the Park concert. The Commission requested that the SES meet again to recommend three acts for discussion at the meeting on June 9th.

Commissioners discussed the inviting four vendors to provide hospitality at the Festival, including cold beverages, fruit ice and ethnic foods. Food trucks, rolling carts, and service trailers were all supported. Commissioners Poole, McClain, Paget and Fuller agreed to take the lead rolls in identify these vendors. Commissioners will report at the meeting in June, continue discussion and finalize their list of preferred hospitality vendors.

Commissioners reported no donations, but inquired about the ability to collaborate with local restaurants to raise funds. Staff will consult with the City Attorney's Office and provide a response. Commissioners agreed to set a July deadline to meet their individual fundraising goals of \$429, towards the collective goal of \$3,000 in support of the Festival.

Motion made by Commissioner Fuller, seconded by Commissioner Sandhu to approve the recommendations. Voice vote found all in favor; motion carried 7:0.

DISCUSSION

The Commission will present the Tracy Arts and Culture Festival as the final event of the 2015 Music in the Park summer concert series to be held on Saturday, August 1st from 10 AM to 2 PM in Lincoln Park. The Tracy Arts and Cultural Festival pilot event will present three invited headlining acts to perform on stage for 40 to 45 minutes each. The Tracy Arts Commission will invite three to six arts and community organizations to participate in the event providing support in the form of matching tents, booths, tables, chairs, etc. The Arts and Culture Festival pilot event will include a hands-on and/or participatory activities area in support of educational components. The Tracy Arts Commission will invite four vendors to provide hospitality services in support of the event. The Tracy Arts Commission will staff an information/welcome booth and host the event at large.

The Commission has approved a \$6,000 budget for the 2015 Festival with an appropriation of \$3,000 from the anticipated FY15-16 budget and a \$3,000 fundraising goal. Staff has estimated expenses as such:

\$2,500	Main Stage/Headliner Talent Fees
\$2,000	Tents/Booths/Tables/Chairs/Etc.
\$1,000	Marketing/Promotions
\$500	Insurance/Hospitality/Labor/Misc.

The Commission has requested a standing agenda item to continue discussion as the programming develops and to provide updates on their fundraising efforts.

The Commission has agreed to finalize the invited event collaborators, three headliner acts and four hospitality vendors at the meeting on June 9th.
