## APPOINTMENT OF COMMISSIONERS TO THE FOLLOWING SUBCOMMITTEES: BUDGET, CIVIC ART, AND SPECIAL EVENTS

#### **DISCUSSION**

Tracy Arts Commissioners serve one-year terms on Subcommittees. Terms begin in January and commence in December annually. Subcommittees work with staff to schedule meetings as needed. Commissioners may volunteer to serve Subcommittees and/or the Chair may appoint Commissioners to serve.

#### **Budget Subcommittee:**

The Budget Subcommittee provides input to staff for the upcoming budget process coinciding with the fiscal year running from July to June. The Budget Subcommittee typically meets in the first quarter of the year and thereafter as needed.

Two Commissioners will serve a one-year term.

#### Civic Art Subcommittee:

The Civic Art Subcommittee works with staff to identify priority projects for civic art, applicable capital improvement projects for artistic enhancement, evaluates, artist concepts and proposals, and served as ambassadors to the community-at-large regarding the Civic Art Program. The Subcommittee forms larger project teams as needed with community members and technical experts as projects demand. Meetings are scheduled as needed in relationship to current and future projects.

Three Commissioners will serve a one-year term.

#### **Special Events Subcommittee:**

The Special Events Subcommittee works with staff to develop the annual Music in the Park summer concert series and selects Emerging Artists. In addition, this Subcommittee works to develop multi-cultural programming. The Subcommittee meets several times a year with staff to review talent and make recommendations on the preferred choice of performers and genre each summer. The recommendations are presented to the Commission by April for review and approval. Staff secures the performers and schedules the events.

<u>Music in the Park:</u> The Tracy Arts Commission has presented Music in the Park for over a decade. 2016 will be the 16<sup>th</sup> anniversary season. The concerts are typically held in Lincoln Park across six to eight consecutive Thursdays in June and July. Each week a different genre is featured. The concerts begin at 7:00 PM and last approximately two hours each. Talent fees range between \$1,000 and \$2,000 per performance.

<u>Emerging Artists:</u> Emerging Artists are young performers under the age of 18 who are invited to sing the National Anthem prior to each summer concert. The Tracy Arts Commission conducts a cappella auditions for youth in the early spring and staff schedules the preferred artists to perform at events.

<u>Tracy Arts & Cultural Festival:</u> The Tracy Arts Commission has offered past Multi Cultural Festivals at both Lincoln Park and the Grand Theatre Center for the Arts. In 2015 the Commission developed a new pilot event held in August in Lincoln Park, which included educational and interactive components, regional headliner performers and community collaborations. The Commission intends to grow this event annually by seeking grants, sponsorship and underwriting support.

Three Commissioners will serve a one-year term.
