Commissioner Poole will bring additional samples and cost information to the meeting on March 8, 2016. Commissioners requested an agenda item to review and approve purchasing Tracy Arts Commission shirts at their own expense.

2. DISCUSS AND RECOMMEND FY2016-17 BUDGET RECOMMENDATIONS FOR TRACY ARTS COMMISSION PROGRAMMING

CAM Wilson provided a budget worksheet for the Subcommittee to review FY2015-16 estimated expenses and assist in formulating FY2016-17 recommendations. Commissioners then considered projected revenue and estimated expenses for TAC programming.

Commissioners discussed the need to modestly increase revenue through fundraising in the amount \$721, \$103 per Commissioner. The Subcommittee identified the need to assess ten booth rentals at a fee of \$125 each in order to grow the Tracy Arts & Cultural Festival accordingly. Additional discussion included cutting expenses to the Music in the Park summer concert series with funding to support four concerts with modestly lower talent and hospitality expenses.

The Subcommittee also agreed to lower the talent fees for headliner performers at the Tracy Arts & Cultural Festival to \$2,000, a \$500 decrease from FY2015-16. The Subcommittee felt the continued expense of \$450 to support artist hospitality at the Downtown Tracy Artwalks is valuable.

CAM Wilson explained the two large-format bronze sculptures in the City Art Collection on Central Avenue are recommended for cleaning and waxing by a professional company this year and has estimated that expense to be \$1,000. The work can be scheduled at an appropriate time of year, weather dependent.

CAM Wilson recorded all of the Subcommittee recommendations on the budget worksheet, which will be presented as exhibit with an action item at the meeting on March 8, 2016.

- 2. to present the Music in the Park summer concert series on Thursdays, June 30th, July 7th, July 14th and July 21st at 7 pm in Lincoln Park. Preferred genres of music are County/Folk, Latin, Jazz, R&B/Soul, Pop/Rock/Party and Reggae/Ska.
- 3. to present the Tracy Arts & Cultural Festival on Saturday, July 30th from 12 to 4 pm in Lincoln Park. Seven to ten community collaborators should be invited, including those that participated in 2015. Three headliner acts and two community-based acts should be presented with headliners on the main stage and community performers on the grounds, scheduled in-between headliners. Three hospitality vendors should be invited to provide Mexican/Latin, Asian and Indian food and beverages. The City Staff and the TAC should host the central activity tent and allow scheduled community-collaborator usage throughout the event. Ten additional booths should be available to grow the Festival with five dedicated to artists/crafters/non-profits/social/community groups and five

Tracy Arts Commission Programming Outline:

Emerging Artists

1. to present the Emerging Artists program with auditions to be held on Saturday, April 23rd from 10 am to 12 pm, and on Saturday, May 7th, 2016 from 12 to 2 pm at the Grand Theatre Center for the Arts.

Performers will be sought to sing the National Anthem at each of the Music in the Park summer concerts as well as the Tracy Arts & Cultural Festival. In addition, should the auditions identify additional performers, vocalists can sing a song during intermission at each of the summer concerts.

Music in the Park

2. to present the Music in the Park summer concert series on Thursdays, June 30th, July 7th, July 14th and July 21st, 2016 at 7 pm in Lincoln Park.

Preferred genres of music are County/Folk, Latin, Jazz, R&B/Soul, Pop/Rock/Party and Reggae/Ska.

Tracy Arts & Cultural Festival

3. to present the Tracy Arts & Cultural Festival on Saturday, July 30th, 2016 from 12 to 4 pm in Lincoln Park.

Seven to ten community collaborators should be invited, including those that participated in 2015. Groups can partner in booths if needed.

Three headliner acts and two community-based acts should be presented with headliners on the main stage and community performers on the grounds, scheduled in-between headliners.

Three hospitality vendors should be invited to provide Mexican/Latin, Asian and Indian food and beverages.

The Cultural Arts Division and TAC should host the central activity tent and allow scheduled community-collaborator usage throughout the event.

Ten additional booths should be available to grow the Festival with five dedicated to artists/crafters/non-profits/social/community groups and five dedicated to retail/commercial vendors. Booths will be available on a first-come, first-served basis for a fee.
