3. DISCUSS ON-GOING DEVELOPMENT OF EMERGING ARTISTS, MUSIC IN THE PARK AND THE TRACY ARTS & CULTURAL FESTIVAL

Commissioner Dhugga announced that she could not Emcee the upcoming concert on Thursday, July 21st. Commissions Jones and Swanson agreed to cover the duties.

Commissioners agreed the immediate audience for the second concert on Thursday, July 7th doubled to approximately 200 in attendance, with the inclusion of an appreciation picnic hosted by a local realtor, Donna Baker for her clients. Commissioner Swanson offered the potential to engage other community businesses and organizations should be developed going forward. Commissioner Dhugga expanded upon the idea to develop a work plan to create a formal small business marketing opportunity. Commissioner Swanson would like to see a banner sponsorship program in the \$150–\$300 range. Commissioner Fuller would like to consider Sparkles the Clown at future concerts. Commissioners requested a future agenda item to discuss these ideas.

Commissioner Sandhu stated concern over the sound quality at the first concert on Thursday, June 30th. Commissioners agreed but noted the issue was addressed with additional PA equipment and had greatly improved at the second concert.

Commissioners discussed and agreed to take assignments to act as host to each of the participating Community Collaborators at the Arts & Cultural Festival. Commissioners identified additional community groups for consideration including Animal Rescue of Tracy and a Tracy Afghan community organization, should a

CONSIDER OPTION TO PRESENT A TRACY ARTS COMMISSION ANNUAL REPORT TO CITY COUNCIL

BACKGROUND

On July 5, 2016, the City Council heard a Staff report updating them on the role and responsibilities of City Commissions. Those Commissions include the Planning Commission, Measure E Residents' Oversight Committee, Parks & Community Services Commission, Transportation Advisory Commission, Youth Advisory Commission, and Tracy Arts Commission. After some discussion about the report, Council decided that each Commission that does not already present an annual report to Council should have the option to present annually to the Council if there is agreement by that Commission to do so.

DISCUSSION

Council indicated that the Planning Commission does not need to present an annual report to as they receive information from Planning Commission activity at nearly every Council meeting.

The Youth Advisory Commission (YAC) shares an annual report with the Council every January and, while Staff prepares the report and presentation slideshow, the YAC is the only Commission where Commissioners present their report in-person. The Measure E Residents' Oversight Committee presents an annual written report documenting its findings to the City Council in February of each year. The final report will take place in 2017.

Parks & Recreation Department Staff prepares the Senior Citizen Annual Report and slideshow for the City Council, which takes place in January of each year, but Commissioners for the Parks & Community Services Commission are not involved in the presentation itself.

Neither the Transportation Advisory Commission, nor the Tracy Arts Commission, presents annually to City Council.

Should the Tracy Arts Commission decide to exercise the option of preparing and presenting an annual report to Council each year, it would need to determine the following:

1. Tone of the report (metric-based, anecdotal, or a hybrid)

- 2. Identify needed resources such as Staff time, computer access, photos, etc.
- 3. Select a time of year to present report annually

As the Tracy Arts Commission does not currently present an annual report to City Council, Staff encourages the Tracy Arts Commission to discuss the following:

- Does the Commission need to present annually, or is there sufficient communication of issues between the Commission (via Staff) and the Council regarding issues that the Commission addresses?
- Are Commissions willing to develop and work on a plan to meet a goal for delivering an annual report to City Council each year?

Department Staff would need to be involved in the process of developing and writing an annual Tracy Arts Commission report, which would include the writing of a Staff report, creating support materials and/or presentations. This would task Staff with additional responsibilities in support of the Tracy Arts Commission.

There is no fiscal impact to the General Fund for this item at this time.
