Commissioner Dhugga stressed the need to develop a new marketing plan, as reflected in the recommendations. This should include one-to-one (personal and educational) communication with the public, social media, cultivating business relationships and visiting with the immediate neighborhoods of the event locations. Commissioners were in support of adding these efforts to the existing marketing, which has traditionally included electronic and print distribution and newspaper advertising. CAM Wilson advised the Commission that the City of Tracy recently adopted NextDoor as a social media platform for neighborhood-level communication and that they may want to consider joining.
