- Thursday, July 27<sup>th</sup> Dr. Powers Park
   Friday, August 11<sup>th</sup> Downtown Park Plaza (in collaboration with the Artwalk)

CAM Wilson advised there could be sound concerns from the adjacent neighborhood in using of Veteran's Park.

Commissioner Poole will visit Cecliani Park and report back to the Commission in March.

Commissioners identified preferred hospitality novelty vendors including Kona Ice. Pink Turtle Ice Cream and Aldos Gelato. Commissioners supported the inclusion of two community organizations and one commercial business at each concert. In addition they felt the purchasing of three pop-up canopies would be a good investment to help support the event components. CAM Wilson suggested the cost of approximately \$600 could be split between the TAC and the Arts Education Program who could also utilize canopies at other public events.

Commissioners felt that the development of a marketing program for event sponsorship would be a good tool for engagement and fundraising in the future. Sponsorship could be tied to a promotional give-away at each event. The Commission will revisit sponsorship ideas when they debrief the 2017 concert series, in preparation for the 2017-18 series.

### 4. CONTINUE DISCUSSION OF NEW YOUTH PROGRAMMING FOR 2017-18

Commissioner Dhugga led a second discussion for the Tracy Arts Commission to consider developing new programming designed to appeal to youth (age 12+) audiences, and to collaborate with youth groups (through the schools), in 2017-18.

Commissioner Dhugga supported the idea of collaborating with the Youth Advisory Commission, and offered to attend a future YAC meeting to present the concept of the programming. She stated the TAC is the proper community group to lead this project. Commissioners agreed that reaching out to the YAC was a good idea and she should move forward with contacting them.

Commissioner Poole briefed the group on the Festival of Cultures held at Kimball High School on February 3<sup>rd</sup>.

Commissioner Fuller suggested the option of tabling discussion on this item until after Music in the Park was completed this year. Commissioners discussed this option but felt comfortable keeping the potential new programming as an active discussion item in order to keep the conversation going.
