CONTINUE DISCUSSION OF 2019 PROGRAMMING

Commissioners shared and discussed ideas for new programming in 2019.

Commissioner Fuller wanted the record to state that she felt it was a mistake and is 100% against getting rid of Music & Picnic in the Park, as a core TAC event. She felt the low attendance was due to fire and haze in the region. Commissioner Fuller suggested the Commission conduct a community survey via letter or utility bill to gain input.

Commissioner Sandhu stated that the Commission should have specific ideas and questions if asking for public feedback. Instead, he supports change that will attract new and different audiences and cultures in the community.

Commissioner Lees stated that the public already let the Commission know how they felt about the concert series, as they were not interested in attending. She cited the continued success of the Block Parties and stated the TAC has no reason to replicate similar programming.

Commissioner Bordes-Soto stated that programming on Thursday does not appeal to the commuter-lifestyle of the community. She supports new efforts to bring arts programming to the public.

Commissioner Bordes stated the TAC should operate within their purpose and mission, and be part of the redevelopment of downtown supporting the creation of an arts district. Commissioner Bordes suggested the TAC should do more than a presenting series, and instead be experts on the arts, engaging in conversations about redevelopment and arts education. He would like to see a granting program return in order to help artists and arts organizations.

DISCUSS AND APPROVE PARTICIPATION IN DOWNTOWN ARTS WEEK 2019

CAM Wilson presented this Staff item for the Commission's consideration, stating this new event series could serve as a platform for the TAC to engage the public, as well as interact with the local creative community and the business community in downtown. Commissioners voiced support as this project mirrors the on-going discussion about new arts programming in 2019.

CONTINUE DISCUSSION OF 2019 PROGRAMMING

DISCUSSION

The Tracy Arts Commission (TAC) met on September 11, 2018 to continue discussion of summer 2018 programming. Commissioners reported observations and feedback in effort to evaluate the success of the Music & Picnic in the Park – Summer Concert Series.

As a result, Commissioners agreed the event series did not meet its goals, is no longer relevant to the community, and to immediately begin a new development process in consideration of 2019 programming. The goals of this process are to provide Commissioners with a better understanding of the mission and role of the TAC in the community, and to develop new and more meaningful programming in 2019.

Commissioners agreed to begin discussion at the meeting of October 9 and maintain a standing agenda item forward in order to work on this project in a timely and effective manner. In November, Commissioners confirmed participation in Downtown Arts Week, a celebration of Tracy's cultural offerings between April 13th and 19th, 2019.
