1. DISCUSS TRACY ARTS COMMISSION 2019-20 BUDGET RECOMMENDATIONS

DISCUSSION

The Tracy Arts Commission (TAC) has adopted new programming recommendations for 2019 with the goals of creating new, small event series featuring and supporting the local creative community, as well as promoting civic art and downtown re-development. Projects will include participation in Downtown Tracy Arts Week (April 13 – 20, 2019), participation in the Downtown Tracy Artwalks (summer/fall 2019), development and/or support of arts appreciation and arts-as-healing associated with veterans in the community, and the development of a youth arts festival. In addition the TAC will be developing a participatory role in the Downtown Tracy Mural Project through the Civic Art Program, and designing a new Granting Program to help support local artists and arts programming in the community.

The Budget Subcommittee (BS) is charged with reviewing the 2019-20 budget with Staff in order to create recommendations in consideration of programming goals and projects commencing in 2019 and continuing into 2020. BS recommendations will be presented at the regular meeting on Tuesday, March 12, 2019 for TAC review and approval.
