
Pursuant to Section 54956 of the Government Code of the State of California, a Special meeting of the **Tracy City Council** is hereby called for:

**RECEIVE A PRESENTATION ON THE PROJECT STATUS OF THE GEOGRAPHIC INFORMATION SYSTEM (GIS) IMPLEMENTATION AND RELEASE OF THE PUBLIC GIS WEBSITE**

EXECUTIVE SUMMARY

This is a Council presentation to preview the current status of the City's GIS Website prior to it being accessible to the public. The GIS website will offer residents, developers, brokers, and businesses access to useful information and tools to view a clear picture of the City and allow answer to questions that might otherwise generate calls to City Staff.

DISCUSSION

During the City Council Goal Setting Workshop conducted on February 19, 2008, and subsequent review workshop on April 15, 2008, the City Council identified implementation of a Geographic Information System as one of the critical infrastructure projects for the City. Also, the City of Tracy is required to comply with Federal CMOM Regulations. The GIS project is needed to comply with regulatory requirements related to sewer system evaluation and capacity analysis. The implementation of the GIS project will benefit Tracy citizens by providing reliable information about City's assets and services and greatly benefit the business community by providing business critical information on the City's website. Developing a Citywide GIS is a collaborative effort that includes all Departments within the City of Tracy and provides a common platform for the City to provide efficient and effective service to Tracy citizens. The GIS Team has been working to build the Citywide GIS project over the last two years.

This is a special presentation to Council to provide a preview of City's GIS Website before it is open to the Tracy residents. GIS website will provide the public access to useful information and tools to see a clearer picture of their city and allow them to answer some of the questions that might otherwise generate calls to City Staff. The Public GIS Website will also provide developers, brokers and businesses access to city assets and demographic information, which will ultimately increases economic development activities in the City. The GIS website will consist of several web-based applications that provide powerful search tools to the Tracy residents to find parks, parcels, city facilities and other points of interest. City's GIS project team completed the initial stages of Website development and is looking forward to receiving comments from the Council prior to opening it to the public.

City staff also has planned a demonstration of the GIS website to select external stakeholders such as developers, engineers, planners, real estate agents and the Tracy Press. Several demonstration meetings are planned during the 3<sup>rd</sup> and 4<sup>th</sup> week of September. Current plan is to receive comments from Council and external stakeholders, update the GIS website and open it to the Tracy residents in early November.
