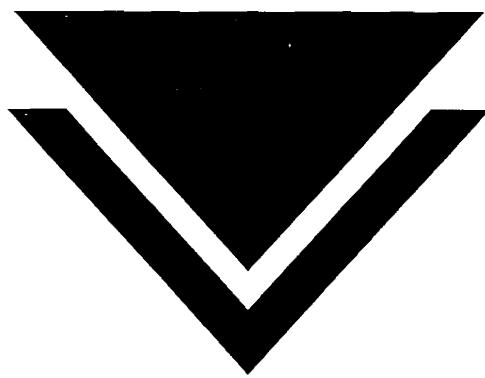


# PETITION

This petition is to ask the Tracy City Council to require staff to enforce Leprino Foods "Use Permit" that pertains to NOT being harmful to the neighbors. Us neighbors of Leprino Foods still have noise issues that have a detrimental health effect, mainly noise disturbance from the refrigerated railcars being run all thru the night and railcar deliveries during what should be quiet hours for the residential neighborhood. There is also a noise issue with some of the roof top equipment that should be behind parapet walls per Leprino's CUP but again our city staff refuses to address at least the most offensive ones. This is the fourth petition in two years addressing the same issues as staff has yet to follow up with any neighbor to investigate our claims.
