

In the near future, you will participate in a Study Session to consider and prioritize Capital Improvement Projects for the coming fiscal year. Within the list of projects are improvements to, or the replacement of, the Lolly Hanson Senior Center, located at 375 East 9<sup>th</sup> Street. As you consider the multitude of requests you receive to prioritize the limited financial resources available for Capital Improvement Projects, please take into account the following:

- 1. The Lolly Hanson Senior Center was built in 1987.
- 2. Over 3000 Senior Citizens use the Lolly Hanson Senior Center each month.
- 3. There are 220 fitness classes each month, some with over 60 participants.
- 4. There are 60+ specialty activities monthly such as painting, bridge and self-defense.
- 5. About 375 lunches are prepared at the Center monthly.
- 6. The current Senior Citizen population of Tracy exceeds 10,000.
- 7. By 2030 the US Census Bureau projects the Senior Citizen population of the United States will more than double.

Recently, my fellow Senior Citizens who believe the Lolly Hanson Senior Center no longer meets our needs began collecting signatures from residents of Tracy. Some of those signatures are attached. Had there been more time, we're confident this "Grass Roots Effort" could have collected substantially more signatures from a cross-section of Tracy residents who believe there is a need to make a new facility a top priority.

Attached you will also find pictures from inside the current facility that reflect the almost 30 years of wear and tear. There is insufficient space, minimal storage that requires tables and chairs to take up valuable space in the ONLY large room in the facility and significant signs of aging.

We're fully aware there are always more Capital Improvement Projects than funds, but as Senior Citizens who have paid their share of taxes over the years – many of whom helped build the City of Tracy during both good and bad times – we wish to voice our wishes directly to each of you prior to your considering this issue. There is a large underserved population of Senior Citizens in the City of Tracy that needs services the Lolly Hanson Senior Center offers, but unless this building is replaced by a larger, more "user friendly" building, City Staff can't be expected to reach out to that population. The building no longer meets the needs of its current users and adding additional users the building can't support makes little sense, thus leaving a huge gap in service to a large population of the City of Tracy.






