Due to the COVID-19 emergency, the regular meeting was conducted pursuant to the provisions of the Governor's Executive Order N-29-20, which suspends certain requirements of the Ralph M. Brown Act. Residents participated remotely via email, phone and WebEx during the meeting.

Mayor Rickman called the meeting to order at 7:01 p.m.

Mayor Rickman led the Pledge of Allegiance.

Pastor Doug Diestler, Mission City Church offered the invocation.

Roll call found Council Members Arriola, Ransom, Vargas, Mayor Pro Tem Young and Mayor Rickman present.

Council Member Vargas pulled the item to ask where the City is regarding creating a Citywide LMD or CFD that would be easier to manage and maintain the levels of landscaping and service.

Jenny Haruyama, City Manager and Brian MacDonald, Parks & Recreation Director responded to Council Member Vargas's question.

No one from the public wished to speak.

- ACTION: Motion was made by Council Member Vargas and seconded by Mayor Pro Tem Young to adopt **Resolution 2020-100** approving the Preliminary Engineer's Report regarding the proposed levy and collection of assessments for the Tracy Consolidated Landscape Maintenance District, pursuant to the provisions of the Landscaping or Lighting Act of 1972 for Fiscal Year 2020/2021. Roll call vote found all in favor; passed and so ordered.
- ACTION: Motion was made by Council Member Vargas and seconded by Mayor Pro Tem Young to adopt **Resolution 2020-101** declaring the City of Tracy's intention to levy annual assessments for the Tracy Consolidated Landscape Maintenance District, Fiscal Year 2020/2021 and setting a public hearing on July 21, 2020 at 7:00 p.m. to consider same in

accordance with the Landscaping and Lighting Act of 1972. Roll call vote found all in favor; passed and so ordered.

Ed Lovell, Management Analyst provided the staff report.

Alvin Vaughn pulled the item to ask how much the customer fare will be to use the on-demand service.

Jacob Hunter requested that Council make sure that the term is put out for RFP. Mr. Hunter added the City has not put the contract for transportation out to bid for two years.

City Council questions and comments followed.

- ACTION: Motion was made by Mayor Pro Tem Young and seconded by Council Member Ransom to adopt **Resolution 2020-103** approving Amendment No. 3 to the Professional Services Agreement with MTM Transit, LLC, extending the contract for one year. Roll call vote found all in favor; passed and so ordered.

Council Member Arriola pulled the item to clarify that the funding for the School Board and funding for the City are different. Council Member Arriola added it is a good opportunity to collaborate with the School District and demonstrate commitment to our youth. It is going to be a pilot program to support students riding on our buses.

Alvin Vaughn pulled the item to express support for the creation of a program to provide free bus fares for students stating it will increase ridership and relief to household expenses during COVID-19. Mr. Vaughn provided a link to Mass Transit Magazine.

City Council questions and comments followed.

- ACTION: Motion was made by Council Member Ransom and seconded by Mayor Pro Tem Young to adopt **Resolution 2020-104** authorizing the submittal of a project nomination and allocation request for the Low Carbon Transit Operation Program (LCTOP), the execution of the certifications and assurances and authorized agent forms for LCTOP for the following project: Free Student Fares, \$67,962. Roll call vote found all in favor; passed and so ordered.
- 2. ITEMS FROM THE AUDIENCE Cayley Castro submitted a comment demanding the City Council put a required mask ordinance in place. Ms. Castro shared her concerns regarding City Council's decision to not put a required mask ordinance in place.

Ron K congratulated Council for reimaging City Council meetings and would like to continue with virtual meetings. Ron thanked Council for the MacArthur expansion and the bicycle lanes. Ron proposed reimaging Tracy yard waste into Tracy composting and working with staff to pioneer a movement to help create a Tracy composting bin.

Arabella McCreary referred to the sublicense under cannabis cultivation brought up at the last meeting stating that at the state level the cannabis cultivator is allowed to process but a processor type license is not allowed to cultivate. Ms. McCreary added it is important to consider adding as a sub-permit to the cultivation.

Lea Austin requested that Council place COVID related items earlier in the agenda. Ms. Austin also requested an ordinance related to wearing face coverings and shared her disappointment regarding Council's failure to require members of the public to wear face masks.

Robert Tanner expressed his concerns regarding fireworks and suggested the City should ban all safe and sane fireworks. Mr. Tanner stated he looked forward to City Hall reopening. Mr. Tanner spoke about no penalty for not wearing face coverings.

Nancy shared her concerns about protection for seniors and people with compromised immune systems and requested Council reconsider their decision and take action to require everyone that goes into a public facility to wear a face mask.

Angelo Alejandre spoke about divesting funds over time from the Tracy Police Department in favor of reinvesting some of the \$30 million plus into problems currently "solved" or a lack thereof, by Police in the city.

Nathan Tran spoke about a petition that is being circulated to set aside resources for a new community center. Mr. Tran challenged Council to meet with Tracy's youth and figure out a path that uplifts our most at-risk youths, allows Police to focus on being Police rather than armed social workers, and a path that says that Black Lives Matter.

Celouky stated the youth of Tracy are petitioning to divest some of the Police Department's budget into a community center catered to youth and their families and want the City to protect and serve given the resources they desperately need which is a community center with all those programs. Camille McDaniel spoke on behalf of the youth of Tracy who are advocating for divestment of Police funding and investment in youth development. Ms. McDaniel stated the youth of Tracy and supporters are petitioning the City to allocate funding that would otherwise go towards a Police budget, and develop a community center with programming that centers the needs and interests of underserved community members.

Jenny Haruyama, City Manager provided the presentation outline.

Karin Schnaider, Finance Director continued with the presentation.

Ken Nordhoff, HDL Companies provided information regarding sales tax assumptions and factors.

Mayor Rickman opened the public hearing.

Robert Tanner referred to property taxes in the budget and asked what percentage increase did staff use for new property. Mr. Tanner questioned whether the City is being too aggressive when saying they will reimburse Measure V funds within two years.

Alice English spoke about delays by Surland regarding the aquatic center and urged Council to look again at the budget to finish Legacy Fields.

Mayor Rickman closed the public hearing.

City Council questions and comments followed.

- ACTION: Motion was made by Council Member Vargas and seconded by Council Member Arriola to adopt **Resolution 2020-105** of the City Council of the City of Tracy adopting the operating, Debt and Capital budget for Fiscal Year 2020-2021. Roll call vote found all in favor; passed and so ordered.
- ACTION: Motion was made by Council Member Vargas and seconded by Council Member Ransom to adopt **Resolution 2020-106** of the City Council of the City of Tracy establishing Fiscal Year 2020-2021 appropriations limit pursuant to Article XIIIB of the California Constitution. Roll call vote found all in favor; passed and so ordered.
- ACTION: Motion was made by Council Member Vargas and seconded by Council Member Ransom to adopt **Resolution 2020-107** amending the Municipal Budget for Fiscal Year 2019-2020. Roll call vote found all in favor; passed and so ordered.

Mayor Rickman opened the public hearing.

No one from the public wished to speak.

Mayor Rickman closed the public hearing.

There were no comments from City Council.

- ACTION: Motion was made by Council Member Vargas and seconded by Mayor Pro Tem Young to adopt **Resolution 2020-110** approving the City-wide Master Fee Schedule for Fiscal Year 2020-2021. Roll call vote found all in favor; passed and so ordered.

Leticia Ramirez, City Attorney provided the staff report.

No one from the public wished to speak.

City Council questions and comments followed.

- ACTION: Motion was made by Mayor Pro Tem Young and seconded by Council Member Vargas to adopt **Resolution 2020-111** providing for submittal of ballot arguments and rebuttals, authorizing the submission of an argument in favor on behalf of the City Council, and directing the City Attorney to prepare an impartial analysis of the Cannabis Business Tax Measure on the November 2020 ballot. Roll call found all in favor; passed and so ordered.
- ACTION: Motion was made by Mayor Pro Tem Young and seconded by Council Member Arriola to designate the City Attorney, Leticia Ramirez as the author of the

argument in favor of the measure. Roll call found all in favor; passed and so ordered.

(The motion to appoint the City Attorney as the author of the argument in favor of the measure was reconsidered after agenda item 3.E)

3.D <u>RECEIVE AND DISCUSS UPDATE ON THE TRACY CHAMBER OF</u> <u>COMMERCE 4TH OF JULY FIREWORKS EVENT AND PROVIDE STAFF</u> <u>DIRECTION</u>

Brian MacDonald, Parks and Recreation Director provided the staff report.

Robert Tanner shared his disappointment about having safe and sane fireworks this year and hoped that the future City Council will ban fireworks except for the event sponsored by the City or the Chamber of Commerce.

City Council questions and comments followed.

ACTION: Motion was made by Council Member Ransom and seconded by Council Member Arriola to move forward with the 4th of July Fireworks event. Roll call found all in favor; passed and so ordered.

3.E <u>REVIEW APPOINTMENTS TO COUNCIL COMMITTEES AND OTHER</u> <u>COMMITTEES, BOARDS AND COMMISSIONS</u>

Adrianne Richardson, City Clerk provided the staff report.

No one from the public wished to speak.

City Council questions and discussion ensued.

ACTION: Motion was made by Mayor Rickman and seconded by Mayor Pro Tem Young to leave the committees as assigned. Roll call found all in favor; passed and so ordered.

Leticia Ramirez, City Attorney asked Council to adopt a motion to reconsider designating the City Attorney as the author of the argument in support of the cannabis tax measure (Item 3.C), as it is inappropriate for the author of the impartial analysis to also write the argument in favor. Ms. Ramirez suggested designating one or two Council Members to author the argument.

- ACTION: Motion was made by Council Member Ransom and second by Council Member Arriola to reconsider having the City Attorney write the argument in favor of the cannabis tax measure (Item 3.C). Roll call found all in favor; passed and so ordered.
- **ACTION:** Motion was made by Council Member Ransom to nominate Council Member Arriola to author the argument on behalf of the City Council.

Council Member Vargas agreed to a friendly amendment to the motion to join Council Member Arriola in authoring the argument in favor of the cannabis tax measure. Roll call found all in favor; passed and so ordered.

3.F AMEND COUNCIL MEETING PROTOCOLS AND RULES OF PROCEDURE TO REQUIRE AGENDAS FOR SPECIAL MEETINGS TO INCLUDE A "COUNCIL ITEMS AND COMMENTS" SECTION

Leticia Ramirez, City Attorney provided the staff report.

No one from the public wished to speak.

There were no comments from the City Council.

ACTION: Motion was made by Mayor Pro Tem Young and seconded by Council Member Arriola to adopt **Resolution 2020-112** amending Council meeting protocols and rules of procedure to require agendas for special meetings to include a "Council Items and Comments" section. Roll call found all in favor; passed and so ordered.

3.G <u>DISCUSS CITY'S RESPONSE AND DRAFT RECOVERY PLAN REGARDING</u> COVID-19 (VERBAL REPORT)

Jenny Haruyama, City Manager provided an update and presentation on the City's response to COVID-19.

Alice English spoke about restaurants keeping their bars open after food service has ended. Ms. English asked if the City can work with TCCA to make it mandatory to wear face coverings for the first two hours at the Farmers Market, and after the first two hours, make wearing a face covering a recommendation only. Ms. English also asked why the Farmers Market cannot be moved to Central Ave with the vendors in the middle.

City Council questions and comments followed.

Lea Austin spoke about the COVID report being presented late and urged Council to move the information up on the agenda. Ms. Austin referred to her early request to undertake an ordinance discussion and vote on an ordinance regarding masks.

City Council accepted the update.

4. ITEMS FROM THE AUDIENCE – Jennifer Rowell shared her disappointment with the City of Tracy and the Police Department and their response to the citizen's request to adopt eight measures that could reduce the likelihood of Police violence. Ms. Rowell stated Council needed to use their leadership and affirm that Black Lives Matter and take measures to reduce violence and consider the proposal to reallocate funds to support efforts to create a more welcoming community.

- 5. STAFF ITEMS Jenny Haruyama, City Manager announced the National Night Out Organization has moved the National Night Out event to October 6, 2020.
- 6. COUNCIL ITEMS Council Member Ransom stated she was inspired by our young people and energy they have brought to dealing with injustice in this country and speaking about what they have experienced in this community. Council Member Ransom announced the Board of Supervisors will be considering a measure for a marijuana tax that supports youth and programs. Council Member Ransom spoke about five peaceful protests that occurred in Tracy, divisiveness in the community, people trying to divide our Police and citizens, and explained defunding the Police. Council Member Ransom requested staff, the city and Council forward a resolution statement that expresses the City's value that racism and injustice are not allowed inside the triangle, whether it is on a placard, or entry point. Council Member Arriola seconded the request.

Council Member Ransom commended Tracy Community Connection Center for fighting to serve our homeless population. The shower celebration will be on June 18, 2020 from 1:00 - 3:00 p.m. Council Member Ransom supported the community's request to put the COVID update earlier on the agenda. Council Member Vargas supported the request.

Council Member Arriola echoed some of Council Member Ransom's comments and spoke about being approached by Council Member Ransom about implementing and introducing a policy initiative called the Equity Initiative. The initiative would consist of two components –1) conversation regarding Police Policy Reform, and 2) Equity based framework for government to re-evaluate how we do business in the City. This would require a valuation of the effects on the humans in our town and demographics and would allow evaluation of every piece of legislation passed in the City. Council Member Ransom seconded the request.

Mayor Pro Tem Young supported moving the COVID item earlier in the agenda. Mayor Pro Tem Young reported on the Safe Board meeting and the ACE Board. Mayor Pro Tem Young spoke about her request at the last meeting to have community conversation to include youth organizers of different protests, clergy, community leaders, Council, staff, and Police to discuss policies to see where we are lacking and educate the community, and asked how soon the community conversation will occur. Mayor Pro Tem Young wished all fathers a happy Father's Day and wished everyone a happy 4th of July.

Council Member Vargas stated she met the three ladies that organized the peaceful march and that it was nice to see the unity from all walks of life to look for equality. Council Member Vargas provided an update on Valley Link, and also on the Latino Caucus Mid-Year Retreat. Council Member Vargas wished all fathers a happy Father's Day.

Mayor Rickman stated one of our greatest strengths is how we come together in hours of need. Mayor Rickman wished a happy Father's Day to his father and all dads, and a happy 4th of July to all. Mayor Rickman acknowledged Jorge Mendoza, Daniel Miranda, and Fred Cutaia for their heroic action saving a young women's life, whose vehicle was involved in a collision, rolled into an irrigation ditch and filled with water. Mayor Rickman requested the City Manager check the location of the accident at Schulte at Lammers

and put up a barrier or guard rail at that location. Council Member Arriola seconded the request.
