Thank you for all of your hard work on our cannabis ordinance to date. We are very happy with the amendments made and are excited to see how they will be implemented tonight. Looking through the agenda, we have come up with several questions:

- 1. Will the application page requirement be increased and if so to how many pages? We recommend 250-300 to insure that all requirements are met and all pertinent information is gathered for you to make a well informed decision.
- 2. We understand you will be reading many pages in this process and would like to aid your process by suggesting a font size of 12pt. Increasing the application pages, along with a 12 point font size will allow for a more comfortable reading process for you.
- 3. Regarding zoning ordinance and company name: Is the word cannabis itself approved by the city. Many cities have not approved the use of the word cannabis and prefer a more discreet name and logo. What is the city's view on this subject?
- 4. Micro business and retail: It is our understanding that with micro businesses, they may also apply for retail licenses. Does that mean there is the possibility for upwards of 8 retail or will you be awarding only the 4 retail in total? For example, maybe only 2 retail given to solo establishments and 2 to micro businesses? Or all 4 to retail and thus micro cannot be awarded any?
- 5. Of the 4 licenses for each section, is one license designated strictly for local and one for equity applicants with the other two designated for companies other than local or equity?

I have a few comments regarding the agenda item 4.A. for tonight's special meeting. First of all, I want to thank you for being conscious of the needs for social equity in this application process. By raising the number of points awarded for this section, you put action behind your words from previous meetings, showing your support for social equity in Tracy. People are disadvantaged for a long list of different reasons, many of which have been outlined and addressed in the Staff Report. By defining the social equity portion of the application with a variety of possibilities for applicants to receive points for this topic, you will be inclusive in your decision making. On page 17 of the Agenda, question 2. I suggest that you select, Answer a. providing a variety of options to applicants.

I also have a few questions. I did not see in the agenda a discussion on the page limit for the application. I currently understand that the limit is set at 125 pages for the entire application.
