The issue of systemic racism must be addressed by the city council. As a native Tracy resident who is a non-black person of color, I've had my own profoundly negative experiences in this community where my race played an important role including but not limited to:

- 1. Racial slurs directed at myself while in public from strangers, including by children.
- 2. Racial epithets directed at myself by other known persons while attending a public school.
- 3. Failure to address incidents of racial epithets being directed at myself when reported to school faculty.
- 4. Accusations by a white Tracy police officer that I committed a crime, and when provided irrefutable proof that I did not, no apology was offered.

The status quo only serves to disincentivize those who have experienced hate incidents from reporting it to the proper authorities. Such a barrier must be broken down if we are to address a very painful subject in our community honestly and effectively. I urge the council to vote in favor of the equity and empowerment initiative and be prepared to take further action.

The following is my public comment for tonight's special meeting:

I am sure Councilmembers Ransom and Arriola knew the deeply negative reactions that their Equity and Empowerment Initiative would provoke, so I would like to thank them for fighting the right fight.

However, my gratitude and respect does not end there. This initiative could not have been possible without the leadership of some brave young activists, who put aside their summer relaxation plans to cause -- as the late John Lewis would put it -- some good trouble They led thousands of Tracyites towards action. These Tracyites were young and old, people of color and people of privilege, marching in person and speaking online. They all stood up not just against the murders of George Floyd or Breonna Taylor, but also against the broken systems that enable such acts of White supremacist terrorism to happen.

To reiterate, Ransom and Arriola's Initiative is an important step towards fixing these broken systems. I hear so much talk about how George Floyd died in Minneapolis and not Tracy. But I also hear so many experiences from friends who were unfairly treated not just by Tracy PD, but also by Tracy staffers. I've heard cases of profiling based on the color of one's skin, I've seen cases of negligent city service just because of where someone lives, and I've recently read a case of a local police officer who was secretly part of a White supremacist Facebook group throughout the recent protests.

So yes, it's true: Tracy is not Minneapolis -- let it be clear that Ransom and Arriola are trying to keep it that way. Please keep turning their Initiative into reality. More importantly, please keep bringing Black, Latinx, and other long-marginalized voices to the forefront of our city's policymaking discussions. Thank you.
