#### EXECUTIVE SUMMARY

The City Council will receive a presentation from Management Partners on the projected fiscal health of the City's General Fund. This report also includes an update from the City Council Ad-Hoc Fiscal Sustainability Committee, comprised of Mayor-Pro-Tempore Vargas and Council Member Arriola.

The City Council will be asked to consider three actions as part of this agenda item. The first is to adopt a resolution affirming the guiding budget principles developed by the Ad-Hoc Fiscal Sustainability Committee and discussed as part of the January 12, 2021 Fiscal Sustainability Council Workshop. The second action item is to consider a one-year extension of the Council Fiscal Sustainability Ad-Hoc Committee. The third is to provide direction, by motion, about recommended fiscal sustainability strategies proposed by the Ad-Hoc Committee.

#### **DISCUSSION**

On May 19, 2020, the City Council adopted Resolution 2020-067, which formed a Council Fiscal Sustainability Ad-Hoc Committee to guide the development of a long-term strategic plan to ensure the City can meet the growing service needs of the community. The Committee's scope was to provide policy guidance as it relates to the development of a multi-year fiscal sustainability plan to address the City's structural deficit and impacts associated with COVID-19.

In July 2020, the Council appointed Council Members Vargas and Arriola to the Ad-Hoc Committee. The Ad-Hoc Committee met regularly over a period of six months with the City Manager, Finance Director and consultants from Management Partners to discuss the City's fiscal condition and explore long-term strategies to improve the City's fiscal health. Specific discussion items included:

- Governmental Budgeting
- City Adopted Budget
- Financial Forecasting Tools and Practices
- City's 5-Year Financial Forecast
- Budget Policy Framework for Decision Making
- Short and Long Term Budget Strategies
- Tracy Financial Principles.

#### Guiding Budget Principles and Fiscal Sustainability Strategies

As part of the Council Ad Hoc Committee meetings, Management Partners developed and presented a fiscal model that showcased the City's existing General Fund's structural deficit and highlighted the impacts of COVID. The model was developed to provide a high-level overview of current trends and how fiscal policy decisions could potential play out over time. The Ad-Hoc Committee considered a variety of short and long term budget strategies that further informed the recommended guiding budget principles (Attachment A) and fiscal sustainability strategies (Attachment B).

At its January 12, 2021 Council Workshop, the Council was introduced to the City's interactive financial modeling tool and recommended guiding budget principles. The Council directed staff to bring back the guiding budget principles for approval as part of a future fiscal sustainability discussion. The principles are attached to this report for Council consideration.

After careful consideration, the Ad-Hoc Committee formulated various fiscal sustainability strategies to address the City's short and long-term project General Fund deficit. The attached strategies are presented with the following ranking indicators:

= Preferred = Potential = Least preferred

A green dot is the most preferred approach, while a yellow dot indicates a potential approach, but would need further refinement. The red dot is the least preferred approach.

Staff is seeking Council direction regarding the proposed fiscal sustainability strategies and preferences regarding recommended strategy ranking.

#### Extension of the City Council Fiscal Sustainability Ad-Hoc Committee

The City Council approved the initial term of the Ad-Hoc Committee through December 31, 2020. Since the formation of the Ad-Hoc Committee, the Committee has worked with staff to develop proposed guiding budget principles and recommended fiscal sustainability strategies. An extension of the Ad Hoc Committee is necessary to enable the Committee to complete the development of the fiscal sustainability plan and provide guidance on any related fiscal policies for Council consideration. Staff recommends that Council adopt a resolution extending the term of the Council Fiscal Sustainability Ad-Hoc Committee through December 31, 2021 (Attachment C). As an alternative, the City Council may provide other direction to staff.

#### STRATEGIC PLAN

This agenda item supports the Council's 2021-2023 proposed strategic priorities under Governance. Specifically, this item facilitates the development and implementation of a fiscal sustainability plan to address the City's projected General Fund deficit.

#### FISCAL IMPACT

There is no fiscal impact associated with accepting the financial forecast presentation or providing direction to explore recommended fiscal sustainability strategies. The table below reflects estimated targets for each strategy category. The estimated target for preferred strategies (green) could potentially gamer \$13M in savings or increased revenues over the next few years.

## **City of Tracy**

#### **Proposed Guiding Budget Principles**

The Council Financial Sustainability Ad Hoc Committee is recommending that the City Council establish a set of budget principles to guide future policy makers and staff to ensure the long-term financial sustainability of the City. The budget principles that are listed below reflect feedback provided by the Ad Hoc Committee and serve as a starting point for consideration in Tracy. The set that is ultimately approved by Council may result in new or updated Council policy.

Reviewed and discussed with the Tracy Financial Sustainability Council Ad Hoc Committee:

- 1. Ongoing expenditures should be supported by ongoing revenues.
- 2. Reserves and one-time revenues should not be used for ongoing expenditures on a continuous basis.
- 3. Any structural gap in a long-term financial forecast should be addressed in such a way that it is eliminated no later than the final year of the forecast (not to exceed 10 years).
- 4. Consistent with GFOA recommendations, the General Fund catastrophic reserve should be maintained at a minimum of 17% of annual operating revenue/expenditure, in addition to a budget stabilization reserve which should be maintained at a minimum of 13%.
- 5. When capital projects are considered, all associated costs including annual operating expenses and any additional future costs should be identified in order to properly assess future financial impacts.
- 6. Each enterprise fund should reflect the true cost of operations and be self-reliant upon fees and/or use rates paid by ratepayers.
- 7. Activities that are supported by user fees should be fully cost recoverable, except for Councilapproved subsidized programs and events.
- 8. Private development should not be subsidized by public funds.
- 9. In general, it is preferred that discretionary General Fund revenues not be earmarked in order to allow for maximum flexibility when making funding decisions.
- 10. Budget development should be guided by a long-term financial plan proposed by the City Manager and adopted by the City Council and should include such considerations as the cost of deferred maintenance and unfunded liabilities.
- 11. Once adopted, annual budgets should be amended only when necessary and should identify a specific funding source for any new priorities.
- 12. Service level reductions will only be implemented if other strategies are not possible or cannot be achieved in a timely fashion.


