EXECUTIVE SUMMARY

On August 18, 2020 and October 6, 2020, then Mayor Pro Tem Young and Councilmembers Vargas, Arriola and Ransom all made requests to bring back information on Legacy Fields and to revisit the scope of the Multi-Gen Recreational Center, which included the history of Legacy Fields and actionable items related to finishing and/or phasing elements of Phase 1 Legacy Fields.

On January 19, 2021 Mayor Pro Tem Vargas, seconded by Councilmember Davis requested a reconsideration of Measure V dollars to focus on amenity projects that could be easily accomplished.

On March 2, 2021 Councilmember Bedolla, seconded, by Mayor Pro Tem Vargas requested that the Measure V discussion include the opportunities and challenges associated with the reprioritization of Measure V projects. Finally, there was a Councilmember inquiry into the Capital Improvement Program process which will be discussed in this report.

This report will address those Council requests and staff is seeking Council direction on various options for delivering Measure V projects.

DISCUSSION

Measure V Milestones

At the general municipal election in November 2016, the City submitted Measure V, a twenty-year half-cent transactions and use (sales) tax, to provide funding for local city services/facilities (Attachment A). The ballot measure question was as follows:

Measure V – To provide funding for City services/facilities, including: police (911, command, gang/narcotics enforcement, crime investigations, other police services); fire protection, emergency, and other fire services; support services; street, median, and park repair/maintenance; senior/ youth services; planning and business retention/attraction; building facilities (such as parks/sports fields); other general services; shall the City of Tracy enact a $1/2\phi$ sales tax for 20 years, providing \$7 million dollars annually, with citizens' oversight, and all funds spent locally? – Yes/No

The voters approved the revenue measure (63.67% voter support) and the tax went into effect on April 1, 2017. It is currently estimated to generate \$10-\$12 million annually, assuming there is no significant change in the economy.

The following is a timeline of Council actions and direction to date regarding Measure V:

March 2017

• City staff conducted outreach to local service clubs and stakeholder groups to gather feedback from the community on funding priorities for Measure V. In addition to public outreach, a statistically valid community survey was prepared by a 3rd party consultant and distributed during outreach meetings. It was posted to the City website and shared on the City's social media sites for the community atlarge to complete. The survey asked respondents to rank various City service areas to gauge what is of highest priority to residents. Categories included infrastructure and maintenance, community amenities, community development, and general City services. The City gathered a total of 728 responses (electronic and written surveys). A copy of the survey questions and results were presented to Council on October 30, 2017 (Attachment A). Since then, Council has taken several key actions based on community feedback and provided direction to staff on how to spend revenue generated by Measure V.

October 30, 2017

Council prioritizes Measure V projects (Legacy Fields, Aquatics Center, Multi-Generational Recreation Center ("Multi-Gen Rec Center"), Library and Ritter Family Ball Park) and commits 50% of all Measure V funds for debt to finance these amenities (\$10 million Legacy Fields, \$30 million Aquatic Center; and \$40 million Multi-Gen Rec Center), 25% to pay-as-you-go amenities (approximately \$2 million annually) and 25% to operating and maintaining these amenities (approximately \$2 million annually). These projects were identified based on staff outreach, Council discussion, and a community survey.

March 6, 2018

- Council approves major community amenity projects to be funded by Measure V and allocates Measure V funds in the amount of \$4 million (planning and design for the Multi-Gen Rec Center), \$1 million (design for Aquatics Center) and \$1.5 million (design for rest of Phase 1 at Legacy Fields). The Multi-Gen Rec Center is officially added to the Capital Improvement Program Budget and the Parks Planning and Development Manager position is established.
- Council approves a construction contract to construct Phase 1C of Legacy Fields. This includes an appropriation of \$3.66 million from Measure V (Phase 1C is now completed). Council also approves a design contract to complete design for the rest of Phase 1, with \$1.5 million in Measure V funds allocated for that work.

<u>July 17, 2018</u>

• Council awards construction contract to renovate the Lolly Hansen Senior Center, which includes over \$950,000 in Measure V funds. Renovation was completed and this facility is now open.

March 5, 2019

 Council provides staff direction to fund Measure V projects using cash (pay go) in lieu of debt financing.

April 16, 2019

 Council approves a construction contract to construct Phase 1D of Legacy Fields. This includes an appropriation of \$4.9 million from Measure V funds (Phase1D is now complete).

May 21, 2019

 Council approves transferring the deed restrictions from the old antenna farm (previous site of Legacy Fields) located near the current site of Legacy Fields. This includes a purchase of 302 acres at Legacy Fields from the Wastewater Fund using the General Fund (\$1.83 million Measure V) (Resolution 2019-104). Council further directed staff to return with options to pay over time (loan with interest) or within one year.

November 5, 2019

- Council provides direction to Surland Communities LLC (Developer) and staff to develop a Final Conceptual Plan for the Aquatics Center with a not-to-exceed amount of \$65 million, which includes a \$55 million commitment from Measure V funds and \$10 million from Developer. It is important to note that the budget for the Aquatics Center has been adjusted several times over the past three years; Council originally established the project budget in 2017 to be approximately \$41.5 million, which increased to \$54 million in 2018 and \$65 million in 2019. These budget shifts have subsequently extended the anticipated opening of the facility by two years.
- In addition, Council directed staff to prioritize Measure V projects in the following order:
 - Multi-Generational Recreation Center \$40 million
 - Operations and Maintenance of these facilities \$40 million
- Based on this direction and prioritization, Measure V revenue will be committed to the Aquatic Center, estimated at \$10 million (annually). The pay-go funding of the Aquatic Center is anticipated to open in summer2025By making this allocation, the Multi-Gen Rec Center and all other projects (Legacy Fields, Nature Park, Ritter Family Ball Park, Emergency Shelter facility, unforeseen emergencies, etc.) will be deferred until the Aquatic Center project is fully funded.
- The Council also indicated that it wanted to explore other funding strategies to support smaller projects at various locations throughout the City. Council directed staff to utilize any additional funds collected above the projected annual \$10 million Measure V revenue for other projects not on their priority list (this did not happen in 2020). Council also asked staff to provide an update on the Multi-Gen Rec Center Needs Assessment and programming opportunities associated with this project.

<u>June 16, 2020</u>

• Council is informed of the potential fiscal impacts of COVID-19 on projected sales tax revenues. The City Council adopts the FY 2020-21 budget which included a loan of \$2.2 million from Measure V to support General Fund operations.

August 18, 2020

- Staff provides update on Multi-Gen Rec Center needs assessment.
- Council provides staff direction to:
 - Continue to allocate all Measure V funds toward the Aquatic Center project with an estimated opening of 2026 or later, understanding that there will be no available funds for any unplanned needs and/or other Measure V priorities.
 - Expedite Aquatic Center project by phasing the design and construction of certain aquatic elements. Phasing plan to be brought back to Council (*Mitracos* court ruling further delayed the phasing plan).
 - Support of the concept of exploring public-private partnerships to meet the community's recreational needs while maximizing Measure V funds for other key priorities.
 - Fund the Legacy Fields land swap as of June 30, 2020.

March 16, 2021

• Staff amends the FY 2020-21 General Fund budget; eliminating the loan from Measure V and updating the projected transfers to the Measure V Capital.

Major Amenity Project Summaries and Key Historical Actions

Provided below are brief project descriptions, summary tables highlighting key actions each major amenity project and other Council requested items. For a more detailed history, see Attachment B.

Legacy Fields Sports Complex

A master plan for Legacy Fields was created in 2011 to include 166 acres of active recreation area (See Attachment F). Of that area, 72 acres will be fully developed at the completion of Phase 1 and Phase 2 (described in more detail below); leaving the remaining 94 acres west towards Corral Hollow Road as undeveloped land. At this time, staff sees any future development beyond Phase 2 as future planning areas and will track that in the Parks & Recreation Department's longer term CIP planning. A cost analysis has not been completed on the full build out of Legacy Fields. Future projects contemplated for this area will align with the needs identified in the upcoming Citywide Parks, Recreations & Trails Master Plan Update that will be presented to the City Council for consideration in the coming months and/or future Master Plans that are current at the time of project planning.

Outstanding Legacy Fields Improvements Needed to Complete Phase 1

Staff has outlined the progress on Phase 1 above. At the request of the City Council, this report is highlighting the improvements needed to complete Phase 1 of Legacy Fields (also known as Phase 1E). In order to fulfill the Council's vision of making Legacy Fields a "destination" facility that attracts more local play and large regional tournaments, additional improvements are required. While the improvements at Legacy Fields has attracted some regional tournaments, the park users and the community have expressed some additional improvements to enhance the facility. Attachment C provides additional detailed information about the project.

The following improvements are needed to complete Phase 1:

Phase 1E Scope of Work

- a. Eastern Wagon Wheel Improvements (to match Western Wagon Wheel)
 - 1. Fields 3, 4 and 5 fencing and paving
 - 2. Renovation of Field 1
 - 3. Renovation of Field 2
 - 4. Paving, parking lot access and shade structures for all fields
 - 5. Restroom/Concession Building and plaza area
 - 6. Electrical infrastructure work for all fields
- b. Parking Lot Improvements
 - 1. Pave and stripe four (4) existing gravel parking lots
 - 2. Underground electrical infrastructure work for future vehicle charging stations
 - 3. Construct new secondary exit at southern end of complex
 - 4. Construct (1) overflow gravel parking lot

- c. Roadway & Sidewalk Top Seal
 - 1. Slurry seal and stripe spine road
 - 2. Slurry seal and repair existing asphalt sidewalk
- d. Wayfinding, Signage & Sponsorship Opportunities Package
 - 1. Vehicular Approach and Experience
 - 2. Pedestrian Approach and Experience
 - 3. Field Identification Markers
 - 4. Informational Kiosks, Photo ops, Branding
- e. Other Critical Improvements
 - 1. Sump pump to address flooding along Tracy Boulevard
 - 2. Electrical improvements to Maintenance Yard
- f. Optional Improvements
 - 1. Sport field lighting
 - 2. Fully improved overflow parking lot

Phase 1E Budget & Timing

The estimated project cost is \$13,000,000 for items a-e listed above. While optional items (item f: sport field lighting and fully improved overflow parking lot) would increase the estimated project cost to \$17,150,000. Should funding for the project be allocated, staff estimates the project will be out to bid by Summer 2021 and construction starting Fall 2021. It is estimated that it will take approximately 18 months to complete the entire project.

Legacy Fields Phase 2 Planning

Phase 2 focuses on 8 acres of rough graded ground just east of the Eastern Wagon Wheel along Tracy Boulevard. Originally this area was conceptualized for two 90-foot baseball fields, plaza areas and restrooms. Recently this area was also contemplated as the potential site of a gymnasium project to add to the recreational diversity at Legacy Fields. With the construction of any major recreational component in this area, facility access should be expanded to help with traffic flow along with associated street frontage improvements. Additional enhancements to previously developed areas of the complex are also considered within the scope of Phase 2 including: a walking loop through the 72-acre complex, sport field lighting at Eastern Wagon Wheel, vehicle charging stations, and a cricket pitch. While there is no recommendation for funding for this request.

Aquatic Center

A Final Conceptual Plan was adopted by City Council (Resolution 2020-154) with a notto-exceed total project cost of \$65 million, including contingency and soft costs (\$55 million City contribution, \$10 million developer (Surland) contribution). The project will be located on the corner of Corral Hollow Road and Summit Drive in the Ellis development. Council has established the following program element priority, listed in order of importance starting with the most desirable to least desirable:

- 1. 50-meter pool
- 2. Recreation/warm-up pool
- 3. Lazy River
- 4. Water slides
- 5. Toddler area
- 6. Indoor pool (optional)
- 7. Fitness center (optional)

Multi-Generational Recreation Center

A Needs Assessment was conducted in 2018, including public outreach that identified the community's priorities for the project to include: a library and education spaces, teaching kitchen, gymnasium space for a variety of indoor sports, administrative space, multi-purpose space, and lobby/lounge space. Next steps for this project include programming and site selection, cost estimates, and an operational and maintenance study.

Capital Improvement Program (CIP) Outlook and Five-Year Planning

Per an inquiry from a Councilmember, the following section provides background about the City's Capital Improvement Program and how it serves as a tool for the financial planning of construction projects.

The Capital Improvement Program is a comprehensive five-year plan designed to identify projects to develop and maintain the City's infrastructure. It is comprised of current, new and future projects. Current projects are those that have not yet been completed and were funded in the current or prior fiscal years. The CIP also reflects new projects that are to be funded in the proposed fiscal year budget and future projects are new projects that are anticipated to occur in the future that do not have funding allocated but may have funding identified. It aims to provide information on the basis for revenue projections, criteria to determine capital infrastructure needs, and present a broad overview of capital infrastructure needs and funding over the next five fiscal years.

The CIP Outlook is not a budget. The CIP Outlook is a planning tool to assist in budget decisions and the allocation of resources required to meet the City's strategic goals that are critical to core services. By preparing the CIP Outlook, the City can monitor and evaluate funding availability while taking into account new needs that are of priority. The CIP Outlook provides the City Council, key stakeholders, and the public with information prior to the budget meetings to facilitate an informed discussion during the development of a CIP Budget. This document does not include a complete compilation of all departmental or public requests that may be considered in preparation of future annual budgets.

The CIP is organized into groups by the type of project, such as; Traffic Safety, General Government and Facilities, Streets and Highways, Parks and Recreation, etc. Depending on the legal requirements, CIP projects are funded by various internal funding sources and rarely have outside funding sources, like grants or fees. There is no ongoing, dedicated funding source to support General Fund capital projects. In the past, Council has conducted public workshops to review the proposed five-year capital improvement programs utilizing several criteria. However, with the lack of this type of available funding, this has not occurred over the last several years. In 2018, staff reconciled a decade worth of funded and unfunded projects.

Beginning with the FY 2018-19 budget, the CIP list has focused on the remaining funded projects carried forward from prior years, the new City Council Measure V priorities, and projects funded outside of the General Fund. Per previous Council direction, the following projects have active CIPs; Aquatics Center (78054) and Multi-Gen Recreation Center (78178). With the direction from City Council to fund projects as pay-go and the prioritization of the Aquatics Center, the City has not contributed to any other Parks and Recreation projects.

Over the last few budget cycles, departments have begun evaluating capital improvement needs and will be incorporating the five-year CIP outlook into the FY 2021-22 budget planning. The list of capital improvement needs within existing City parks is substantial and the department is working on an implementation strategy as a part of its Citywide Parks, Recreation and Master Plan Update however there is no funding earmarked at this time. Other capital needs for building improvements, streets and road repairs, and utilities will be compiled and categorized. It is up to the City Council to prioritize, with input from the community, other stakeholders, and City staff, capital improvements, replacement, and maintenance projects, as there is a finite amount of funding available per year for these projects, but several unfunded needs. Staff will be

conducting a CIP workshop on April 20, 2021 for Council feedback and consideration. As part of the April 20, 2021 CIP workshop, staff will provide a list of funded and unfunded CIPs.

MEASURE V FINANCIAL OUTLOOK

The following table provides a summary of Measure V expended and committed funds, along with current project balances. This provides a broad overview of projections and project funding over the lifecycle of the 20-year sales tax measure.

RECAP OF CURRENT DIRECTION & POLICY CONSIDERATIONS

Current Council Direction

On August 18, 2020 the Council reaffirmed their desired direction to staff regarding Measure V projects. Council directed staff to continue to allocate all Measure V funds toward the development of the Aquatic Center project (based on the adopted Final Conceptual Plan with not-to-exceed budget of \$65 million) with an estimated opening of 2026 or later, understanding that there will be no available funds for any unplanned

> needs and/or other Measure V priorities. There was also a desire to expedite the project by phasing the design and construction of certain aquatic elements using cash on hand. Council directed staff and Surland to bring back a Phasing Plan in which progress was being made until the *Mitracos v. City of Tracy* court ruling put the project on hold. On March 16, 2021, Council directed staff to negotiate an amendment to the Surland DA which, along with the *Mitracos* decision, may delay the phasing plan.

> Council has also prioritized the construction of the Multi-Generational Recreation Center with a project budget of \$40 million and would like that project to begin immediately following the completion of the Aquatic Center with cash on hand. To date, \$4 million has been committed to that project for design and construction with an estimated balance of \$3.5 million available today. Additional construction funding would begin to accumulate in 2026 and construction is planned to be complete in 2030 or later.

Additionally, the Council supported the concept of exploring public-private partnerships to meet the community's recreational needs while maximizing Measure V funds for other key priorities.

Recent Project Impacts – Legal Changes and Council Actions

Legal Changes: Shortly after that direction the City was served with judgement in *Mitracos v. City of Tracy et al.* The trial court ordered City and Surland to stop implementing the Second Amendment to Surland's DA, which included Surland's design work on the Aquatic Center Phasing Plan and the project was put on hold.

Other key changes include:

- City received \$4 million in community benefit funds dedicated to Multi-Generational Recreation Center (Approximately \$7.5 million available for project now)
- City began pursuing public-private partnership with Tracy Housing Authority with potential of providing recreational programming in the downtown core
- City purchased 300 acres around Legacy Fields
- City ended partnership with Tracy Little League and assumed improvement and maintenance needs for 5 ballfields at Legacy Fields
- City received public requests to complete parking lots at Legacy Fields
- City received public requests to expand directional signage, park lighting, and security upgrades
- Measure V Capital transfers now estimated at \$9-10 million annually

Council Action & Project Status Summary:

Aquatic Center

Measure V funding for the Aquatic Center project is currently on track with approximately 75% of City Aquatic Center contribution needs met by Summer 2024; meets phasing goal (estimated \$45-\$48 million by June 30, 2023). City's full contribution for Aquatics Center will be available by summer of 2026 (estimated \$55 million by June 30, 2025). This projection does assume some Measure V funds are required for operating the Aquatic Center after opening (FY 2024-2025). On March 16, 2021, Council directed staff to work with Surland Communities, LLC to renegotiate terms of the existing development agreement, which will impact terms of the Aquatic Center. This, along with the recent Mitracos v. City of Tracy court decision, may impact the timing and delivery of

Multi-Generational Recreation Center

Staff will begin setting aside Measure V funding for the Multi-Generational Recreation Gymnasium beginning FY 2025-2026; estimates full funding by 2030 (estimated \$40 million by June 30, 2029). This projection does assume some Measure V funds will be needed for operations of the Multi-Generational Recreation Center.

Other Notable Outcomes

Defers improvements of other parks CIPs until after 2029.

POLICY CONSIDERATIONS

Staff is seeking direction regarding whether Council wishes to proceed with its current direction as described above or pursue other alternatives. Potential options include, but are not limited to, budgeting a portion of Measure V to fund Phase 1E (all or a portion) of Legacy Fields and/or the Multi-Generational Recreation Center.

Council could consider the following options:

- <u>Option 1: Current Direction</u> Does the Council wish to continue with the current direction as outlined above, with the understanding that no other capital improvements will be completed until 2030 or later?
- <u>Option 2 (Pay-go Legacy Fields and/or Multi-Gen)</u> Does Council want to consider extending and/or phasing the completion date of the Aquatic Center project by approximately three years to allow for the immediate funding of Legacy Fields Phase 1E and explore phasing of the Multi-Generational Recreation Center with cash on hand? This would defer all other aquatic capital improvements until 2030 or later.
 - Option 2 Next steps:
 - Continue working with Developer (Surland) on Phasing Plan for Aquatic Center.
 - Return with appropriation request for Legacy Fields and/or Multi-Generational Recreation Center projects.
 - Prepare and finalize construction documents for Legacy Fields Phase 1E, then project will be put out to bid.
 - Initiate Request for Proposals (RFP) process for a design consultant to lead process for a recreation center including identifying a location.
- <u>Option 3 (Financing Legacy Fields and/or Multi-Gen)</u> –Does Council want to consider extending and/or phasing the completion date of the Aquatic Center project by approximately one year and finance (debt service) Legacy Fields Phase 1E and explore phasing the Multi-Generational Recreation Center. Defers all other capital improvements until 2031 or later.
 - Option 3 Next steps:
 - Continue working with Developer (Surland) on a Phasing Plan for the Aquatic Center.
 - Return with a financing plan for Legacy Fields and/or Multi-Generational Recreation Center projects.
 - Prepare and finalize construction documents for Legacy Fields Phase 1E, then project will be put out to bid.

- Initiate Request for Proposals (RFP) process for a design consultant to lead process for a recreation center including identifying a location.
- Option 4 (Hybrid of Pay-go and Financing Legacy Fields and Multi-Gen) Does Council want to consider extending the completion date of Phase 1 and 2 of the Aquatic Center project by approximately three years to fund Legacy Fields Phase 1E and full build out of Multi-Generational Recreation Center through a hybrid cash/debt service financing plan.. Defers all other capital improvements until 2030 or later.
 - Option 4 Next steps:
 - Continue working with Developer (Surland) on Phasing Plan for Aquatic Center. Staff and developer will return with a presentation on that plan for Council to review.
 - Return with a financing plan, including an appropriation request, for Legacy Fields and/or Multi-Generational Recreation Center projects.
 - Prepare and finalize construction documents for Legacy Fields Phase 1E, then project will be put out to bid.
 - Begin the Request for Proposals (RFP) process for a design consultant to lead process for a recreation center including public outreach.

Outcomes of Financing Legacy Fields and Multi-Gen Projects

This approach will require a portion of Measure V to repay financing; however, it is possible to structure a minimal impact until after Aquatic Center's first phase is completed. Additionally, financing costs will be offset by inflationary costs of construction anticipated over the next decade.

Outcomes of Hybrid Pay-go/Financing Legacy Fields and Multi-Gen Projects

This approach will maximize available funds on hand to deliver three amenity projects in an efficient manner. It will require a portion of Measure V to repay financing; however, it is possible to structure a minimal impact until after Aquatic Center's first phase is completed. Additionally, financing costs will be offset by inflationary costs of construction anticipated over the next decade.

STRATEGIC PLAN

This agenda item is consistent with the City Council's adopted Quality of Life Strategy and meets the goal of enhancing the City's amenities.

FISCAL IMPACT

Fiscal impacts will vary, depending on Council direction.

RECOMMENDATION

That City Council receive update on the history of Measure V and Legacy Fields, and provide staff direction on Measure V Council requests.

How long have you lived in Tracy?







As a community we need to keep protecting our children. Children are told not to smoke yet, they are exposed to smoke against their will and without their parents permission while on their own property. They are protected from second hand smoke at school, at playgrounds, living in apartment buildings, and even when walking into a store. They need those same protections while at their family owned homes playing in their backyards and sleeping in their rooms. Children deserve to be protected, "the California Air Resources Board classified secondhand smoke as a "Toxic Air Contaminant" in the same category as asbestos, cyanide and arsenic."

CDC, "There is no risk-free level of secondhand smoke exposure; even brief exposure can be harmful to health.1,2,6

Since 1964, approximately 2,500,000 nonsmokers have died from health problems caused by exposure to secondhand smoke." I would like the city of Tracy to make a city ordnance to protect children from exposure to second hand smoke while on their own property from those that do not have permission to expose the child to second hand smoke. Parents have a legal obligation to protect their children against harm, I ask that the city give parents the right to protect our child with city enforced protection. That no child is to be exposed while in their home or on their property to second hand smoke from toxic drifting nuisance smoke known to the state of California to be unsafe at any level. In addition to the toxic nuisance secondhand smoke is, childhood asthma is rising. Both of my children have asthma, secondhand smoke triggers asthma, secondhand smoke kills but, for asthma kids secondhand smoke has a high risk of killing them within minutes of them breathing it. Please, give kids the right not to be killed, give them the right to protect themselves, and the parents the ability to call for help! Make a new city ordinance that protects kid not only at school, at the park, in an apartment, in a car, give them those same rights while sleeping in their bedroom and playing in their own backyards because there is no safe distance... 

• Tracy first contemplates Sports Park at Chrisman Road property.

<u>2006</u>

• City Council authorizes the purchase of 200 acre property (Antenna Farm) from the Federal Government for \$950,000. Feds approve plans for Sports Park.

<u>2007</u>

• Plans for Sports Park at Antenna Farm were halted over health and safety concerns.

<u>2008</u>

- City Council votes in favor of locating sports complex in north Tracy on 1,200 acres of City-owned land (current location known as Legacy Fields).
- Holly Sugar Youth Sports Complex Conceptual Design Approved.
- The City collaborated with various youth sports leagues to explore ways to facilitate the construction sports fields given growing demand. During those discussions, the participating sports leagues determined that by entering into a fair market lease arrangement with the City, they could expedite the development of the fields.

- De Silva Gates Construction awarded construction contract for Phase 1A (earthwork, utilities, drainage, gravel parking lots and road construction).

- Parks & Community Services Commission forms subcommittee for naming youth sports fields.

- Aquatics Center Final Conceptual Plan approved (Resolution 2020-154) with not to exceed budget of \$65 million including contingency and soft costs.
- Council directs Developer and staff to return with a phasing plan.
- City served with judgement in *Mitracos v. City of Tracy et al.* Trial court ordered City and Surland to stop implementing the Second Amendment to Surland's DA, which included Surland's design work.
- October 20, 2020 Council received Update on Aquatic Center.

• City files Notice of Appeal in *Mitracos v. City of Tracy, et al. on* January 15, 2021 thereby staying the trial court's ruling. The Second Amendment to Surland's DA is now in effect and can be implemented during the appeal.



CONSIDER ADOPTING A RESOLUTION APPROVING THE AQUATIC CENTER FINAL CONCEPTUAL PLAN WITH A NOT-TO-EXCEED BUDGET OF \$65 MILLION, INCLUDING CONTINGENCY AND SOFT COSTS

EXECUTIVE SUMMARY

This item requests City Council consider approval, by resolution, of the Aquatic Center Final Conceptual Plan with a not-to-exceed budget of \$65 million, including contingency and soft costs.

DISCUSSION

The City of Tracy and Surland Communities LLC (Developer) are committed to delivering an aquatics facility that meets the needs of our community. Per the current Development Agreement (DA), as amended in 2013 and 2018, between the City of Tracy and the Developer, the Developer is tasked with creating an Aquatic Center Final Conceptual Plan for Council consideration that includes input from the community and City staff. The Developer is also required to dedicate 16 acres of land within the Ellis Specific Plan to the City for the future home of an Aquatic Center and provide a public benefit fee in the amount of \$10 million towards the project. According to the DA, funds contributed by the Developer shall only be used to fund planning, design and construction costs for the project. The Developer has paid a portion of those funds (\$2 million) to the City and those funds are currently being used to cover consultant costs incurred by Developer for the development of a final conceptual plan and design.

On August 15, 2017, the Developer presented a scenario for "Complete Build-Out Option 1C" of the Aquatics Center with an estimated project budget of \$41.5+/- million, which included the \$10 million Developer contribution. The Council directed the Developer and staff to find a way to fund that scenario. This was followed by the approval of the Second Amendment to the Amended and Restated Development Agreement by and between the City and Developer (Second Amendment) in 2018. This revised the not-to-exceed budget to \$54 million, which also included the \$10 million Developer contribution.

On November 5, 2019, the Developer presented a Final Conceptual Plan that included various phasing options at different funding levels for Council to consider. After review, the Council provided Developer and staff direction to revise the plan to meet a new not-to-exceed total project budget of \$65 million (\$55M contribution from the City and \$10M contribution from the Developer) and place program elements in such a way that allows for future expansion. The Council also prioritized the desired program elements in the following order:

- 1. 50-meter pool
- 2. Recreation/warm-up pool
- 3. Lazy river

- 4. Waterslides
- 5. Toddler area
- 6. Indoor pool (optional)
- 7. Fitness center (optional)

For reference, a detailed history related to the Aquatic Center project can be found on the staff report from November 5, 2019 (Attachment A).

As stated above, the Developer hired consultants to prepare an updated Final Conceptual Plan (Attachment B) in accordance with the Second Amendment. The City Council must approve the Final Conceptual Plan in order to commence the preparation of detailed design and improvement plans. The Second Amendment states that if the City:

"decides to modify the [P]lan or add additional features or amenities then the cost of changing the conceptual plan or any design or construction plans relying on the original conceptual plan shall be additive funding provided by the City above the initial Swim Center."

FINAL CONCEPTUAL PLAN

The updated Final Conceptual Plan (Attachment B) includes all of the Council prioritized elements except the Indoor Pool and Fitness Center, which Council previously identified as optional elements, as well as the allocation of spaces for future expansion. The Developer has provided a Design Narrative (Attachment C) that summarizes the Final Conceptual Plan and provides a list of "Initial Elements" and "Future Expansion Elements." It should also be noted that the current plan is projected to exceed the not-to-exceed budget of \$65 million set by the Council.

The plan includes all of the "Initial Elements" referenced in the Design Narrative including a "Play Structure Wet Deck" that has an estimated construction cost of \$5.2 million, which is not included on the Council's priority list. If this element was excluded from the Final Conceptual Plan, the project would be under the directed not-to-exceed budget (including soft costs and contingency). Future expansion is envisioned to include an indoor pool and fitness center, previously identified as *optional* program elements by the Council. Additional future expansion elements are listed in Attachment C, but have not been considered by the Council.

Bidding Approach

Developer recommends soliciting bids for the full build out of the Final Conceptual Plan, including the "Play Structure Wet Deck" and designate it as a Deductive Alternate. If the low bid were to come in over budget for the project, this element could be removed from the scope of work. While this strategy allows the project scope to change based on actual bids received, it will result in extra design costs for an element that may not be ultimately constructed.

Funding & Project Delivery Projections

Based on the full build out of the Final Conceptual Plan, the Developer's consultant design team believes that design and improvement plans will take 6-9 months and construction would take another 24 months. Prior to the Council's decision to expand the project budget from a not-to-exceed amount of \$54 million, the projected opening date of the Aquatic Center was Summer 2024. Due to an expanded project budget of not-to-exceed \$65 million, the project timeline was updated to Summer 2025. Unfortunately, this change, coupled with the negative economic impacts to Measure V due to the COVID-19 pandemic has further delayed the opening of the project, which is now estimated to be Summer 2026. This assumption is based on full build-out of the project at a not-to-exceed project budget of \$65 million.

To expedite the opening of the Aquatic Center, Council may want to consider a phased strategy. As part of the final design process, the project would be designed, bid, and constructed in phases over a period of time as funding becomes available. This approach could allow key elements to be built first, enabling the community to enjoy aquatic amenities much sooner than originally planned.

At the close of June 30, 2020, it is estimated that the City will have accumulated approximately \$18 million in Measure V funds for the Aquatics Center. It is projected that another \$5 million will be generated in FY 2020/21 for a total of \$23 million. Combined with the Developer's contribution of \$10 million and Master Plan fees of \$2 million, the estimated funding for Aquatics Center as of June 30, 2021 is \$35 million. Each year thereafter is estimated to generate approximately \$10 million until the cumulative balance of \$55 million is funded by June 30, 2025. As discussed earlier, electing to use a phased design and construction approach could further expedite the completion of the Aquatics Center.

NEXT STEPS

Once authorized, staff will return to Council to approve a design, funding and construction management agreement that will clarify roles and responsibilities along with phasing options and project milestones. As discussed on November 5, 2019, the design, funding, and construction agreement needs to be updated to conform with the Public Contract Code. In addition, the agreement also needs to reflect the not-to-exceed total budget amount of \$65 million authorized by City Council.

STRATEGIC PLAN

This agenda item is consistent with the City Council's adopted Quality of Life Strategy and meets the goal of enhancing the City's amenities.

FISCAL IMPACT

Fiscal impacts will vary depending on Council direction. Assuming Council approves the Aquatic Center Final Conceptual Plan, in addition to funding design and capital costs, the City will incur substantive annual expenses to operate the facility that will need to be addressed as part of future budget discussions.

RECOMMENDATION

That City Council consider approving, by resolution, the Aquatic Center Final Conceptual Plan with a not-to-exceed budget of \$65 million, including contingency and soft costs.

APPROVE AQUATIC CENTER FINAL CONCEPTUAL PLAN AND AUTHORIZE STAFF AND SURLAND COMMUNITIES, LLC TO PREPARE FINAL DESIGN AND CONSTRUCTION DOCUMENTS FOR THE PROJECT WITH A NOT TO EXCEED AMOUNT OF \$54 MILLION, INCLUDING CONTINGENCY AND SOFT COSTS

EXECUTIVE SUMMARY

This item requests City Council approval of the Aquatic Center final conceptual plan and authorization for staff and Surland Communities LLC (Surland) to prepare final design and construction documents with a not to exceed budget of \$54 million, which includes contingency and soft costs.

DISCUSSION

RECENT AQUATIC CENTER PROJECT BACKGROUND

The City of Tracy and Surland Communities LLC are committed to developing an aquatics facility that meets the needs of our community. Through several years of public input, discussions at Council meetings, the City and Surland continue to work together to deliver a project that will benefit our residents and enhance our quality of life.

In 2018, Council approved a Second Amendment to the Amended and Restated Development Agreement (Second Amendment) with Surland that included various provisions regarding the Aquatic Center. Those provisions include:

- Surland will design the Aquatic Center with input from the community and City staff, with ultimate approval of the final conceptual plan and improvements plans by the City Council.
- Consistent with the original Development Agreement (DA), Surland shall dedicate 16 acres within the Ellis Specific Plan to the City for an Aquatic Center and provide a public benefit fee in the amount of \$10 million for the project. Funds contributed by Surland shall only be used to fund design and construction costs. Surland has paid a portion of those funds (\$2 million) to the City and those funds are currently being used to fund design.
- The City's contribution shall be \$35 million, plus \$9 million of contingency (20% of the total project cost of \$45 million).
- The total funding amount for the Aquatic Center shall be \$54 million (\$44 million from the City of Tracy + \$10 million from Surland).
- Changes to the plans due to any modifications or additions of features or amenities by the City after the final conceptual plan is approved shall be funded by the City and not the Developer's \$10 million contribution.
- The City and Surland shall enter into a design, funding and construction agreement.

Based upon previous Council direction, Surland has been working on a concept plan that includes: location (within the Ellis development), a lazy river, water slides, 50 meter pool, recreation pool, indoor pool, fitness center and toddler area. The proposed amenities were derived from years of public outreach on the project starting as far back as 2007. The estimated project cost in 2018, including soft costs (design, inspection and construction management) and contingency, was estimated to be \$54 million as committed to in the Second Amendment.

RECENT PROJECT COST UPDATE

Upon receiving direction from City Council, Surland refined the Aquatics Center conceptual plan by developing more details on the project amenities such as pool sizes, number of waterslides, etc. They hired Gleeds, a global estimating firm, to provide a detailed cost analysis of the project. During this process, it was determined that the project cost was significantly greater than the \$54 million budget approved by Council in the Second Amendment. Cost drivers include escalating construction costs based on market fluctuations, achieving full-cost recovery and creating a destination facility, as well as managing community expectations. The current cost estimate for full project buildout is approximately \$130 million. Surland has continued to refine the project to provide phasing options. This resulted in three phasing alternatives, updated cost estimates, and estimated project subsidies that Surland will present as part of this agenda item.

FUNDING FOR THE AQUATIC CENTER

As a part of Measure V, a twenty year half-cent sales tax passed by voters in 2016 to fund services and amenities, Council identified three projects to be funded, estimated at \$80 million: Aquatics Center, Multi-Generational Recreation Center, and Legacy Fields Sports Complex. Additionally, at the October 30, 2017 Special Meeting, Council directed staff to set aside 25% of the Measure V proceeds for "pay-as-you-go" or "pay-go" projects (such as community amenities), and an additional 25% of the annual Measure V revenue for the maintenance and operations of such amenities.

On March 5, 2019, staff presented Council several Measure V debt service funding scenarios for consideration. Council elected not to utilize debt financing to fund the amenities, and instead use Measure V "cash on hand," whereby the projects would be phased in over time or through a "pay go" approach. In this scenario, Measure V funds would be collected and set aside until an adequate amount was available to fund a project.

Based on estimates from the City's sales tax consultant and an annual 2% growth assumption, Measure V is projected to accumulate over \$230 million in revenue over the next 17 years. The Council recognizes the community value of the Aquatic Center, among other amenity priorities, and has elected to fund the project via Measure V revenue, including staffing and maintenance costs to operate the facility.

Under the "pay-go" approach and assuming a funding amount of \$54 million, it is anticipated that the Aquatics Center would open by summer 2023. The Aquatics Center

cash flow table below reflects Measure V cash on hand, projected Measure V funds over the next four fiscal years, and additional funds committed to the project. Committed funds include developer contributions via the Development Agreement, funds collected from new development (Plan C), and Council approved funds for peer review consultant costs. Not included in the cash flow table is \$12.5 million in aquatic center impact fees that will be collected over a period of 30 years, beginning in 2024.

In addition, the table reflects approved Measure V staffing costs (with inflation) for a Parks Planning & Development Manager to oversee Measure V projects, and a Senior Park Maintenance Worker assigned to Legacy Fields, and developer funds spent to date for the Aquatic Center preliminary and conceptual design plan expenses. It is important to note that the table does not include any anticipated subsidy or operating expenses; estimated project costs are fluid and will not be more concrete until final design and construction documents and the bid process are complete. Surland and their consultants will provide preliminary information regarding expected subsidies for each of the proposed design alternatives.

AQUATIC CENTER PRIORITY FUNDING SCENARIO

The table below illustrates a funding scenario that commits all available Measure V funds over the next four years to the Aquatic Center project. Should Council elect to pursue this funding scenario, it should be noted that there will be little to no funding for other community amenity projects during this time period.

FINAL CONCEPTUAL OPTIONS DEVELOPED BY SURLAND DESIGN TEAM AND AND OPERATIONAL IMPACTS

Surland has prepared several phased designs (Alternatives 1 - 3) with project costs ranging from \$54 million to \$130 million. Their approach assumes approval of the final conceptual plan at complete build-out (Alternative 3) and an option to phase the project utilizing bid alternates to provide flexibility based on bid results. While this approach seems prudent to expedite the bid process, it likely would increase costs for bid additives. It could also increase up front infrastructure costs for phases that may not be constructed in the near term. In addition, it should also be understood that there are no funds currently available to fund the full build-out (Alternative 3) and alternative funds will need to be identified in the future.

According to WTI Incorporated, a design consultant for Surland, the proposed final conceptual plan (Alternative 3) will create an enhanced quest experience similar to a destination resort. Projections and operating models provided by Surland's design team convey full build-out of the Aquatic Center (Alternative 3), utilizing a privately ran operator. Due to limited time, staff was unable to thoroughly review the consultant's proposed cost estimates and operating assumptions for the phased approaches (including guest entry fees). Based on the feedback gathered from other area aguatics centers, staff anticipates a General Fund subsidy will be needed to operate and maintain this facility, depending on the amenities built and the design elements. General Fund subsidies from area aquatics facilities vary and are typically driven by scope, size, business model and location, which could amount to \$1 million annually. Staff also cautions that some private operators of aquatics facilities have failed in other jurisdictions (La Mirada Splash Aquatics Center), and as a result, public agencies have had to take over operations. Given this, it is important that efforts are taken to ensure that the final design and construction documents reflect an aquatics facility that can be programmed and operated by the City, should the facility revert to City operation. Staff recommends a comprehensive review of facility operations from both the private and public operator perspective.

Staff does not recommend that the Council commit to full build-out (Alternative 3) of the Aquatic Center for the following reasons: 1) the capital and future operating costs of the project are supported through a temporary revenue source (Measure V), 2) projected operational subsidies would create a long-term impact to the General Fund, 3) a \$54 million project budget can deliver the many of the desired aquatics amenities, as seen in neighboring communities.

It is important to note that the construction estimates provided by Surland's consultants are fluid and are for general discussion purposes. Development of the final design and construction documents will help refine those costs, along with the bid process.

Given Council's prior commitment to fund the Aquatic Center, past fiscal discussions on Measure V priorities, lack of funding alternatives, and anticipated operating subsidies, staff recommends that Council approve a final conceptual plan with a budget of \$54 million. The final conceptual plan will help guide programmatic and financial expectations of the Aquatics Center. Working in partnership with Surland, staff believes a final design project budget of \$54 million can incorporate many of the key elements previously identified by Council and the community. It should be noted that committing to a budget amount does not necessarily mean the elimination of desired programmatic elements. The alternatives presented by Surland can be modified to realize Council's fiscal and project goals as it pertains to the Aquatic Center.

NEXT STEPS

Staff recommends that Council authorize staff and Surland to prepare final design and construction documents, including any additional recommended design modifications, within a project budget of \$54 million with the understanding that there is no available funding for future expansion at this time. Staff also recommends that all sizing of infrastructure should be designed to support only the proposed improvements included in a \$54 million project budget and not for future phases, thus maximizing the number of amenities in the project.

Once authorized, staff will return to Council to approve a design, funding and construction management agreement that will clarify roles and responsibilities along with project milestones.

The phased approach to construction will initially provide the core essence and excitement of this unique destination to provide broad appeal to users of all age groups and program interests and needs, which will be enhanced with new features and amenities over time that will continue to grow the interest, attendance and benefits of this resort style park.

The design of this facility is based on the careful and considerate design direction to provide guests a unique experience. This design philosophy provides the users a sense of discovery as they enter the park and can experience a variety of areas that have convenient circulation paths to the aquatic area of the guest's choice. These experiences are set in a well-landscaped area surrounding guests with ample seating accommodations, shade, and an enriched experience for each visit to the park. This enhanced experience will be greatly appreciated by the users whether they are coming to participate in a learn-to-swim program, water fitness class, wellness exercise group, competition, practice or just bringing the family to enjoy some well-deserved time together as a departure from their daily routines.

Initial Elements Include:

RESOLUTION 2020-154

APPROVING THE FINAL AQUATIC CENTER CONCEPTUAL PLAN WITH A NOT-TO-EXCEED BUDGET OF \$65 MILLION, INCLUDING CONTINGENCY AND SOFT COSTS

WHEREAS, In 2013, City and Surland executed an Amended and Restated Development Agreement by and between the City of Tracy and Surland Communities, LLC, recorded in the official records of San Joaquin County, as Document Number 2013-119548 (the "DA"), and

WHEREAS, Among other things, the DA provided for Surland to dedicate sixteen (16) acres of land within the Ellis Specific Plan area to City for a proposed public swim center (the "Aquatic Center"), and to pay to City Ten Million Dollars (\$10,000,000) (the "Developer Contribution") to fund the design and construction of the Aquatic Center. On September 5, 2014, Surland paid Two Million Dollars (\$2,000,000) of the Developer Contribution to City, and

WHEREAS, In 2018, City and Surland executed that certain Second Amendment to Amended and Restated Development Agreement by and between the City of Tracy and Surland Communities, LLC, recorded in the official records of San Joaquin County as Document Number 2018-055247 (the "Second Amendment"). Among other things, the Second Amendment amended the DA to reflect the Parties' agreements that (i) Surland would provide to City design and construction services for the Swim Center equal to and in lieu of paying the remaining Eight Million Dollars (\$8,000,000.00) of its Developer Contribution, and (ii) Surland would facilitate design and improvements plans for the Aquatic Center, and

WHEREAS, Pursuant to the Second Amendment, the City's contribution to the Aquatic Center shall be \$35 million plus an additional \$9 million for contingency that combined with the Developer Contribution totals \$54 million, and

WHEREAS, On November 5, 2019, the Developer presented a Final Conceptual Plan that included various phasing options at different funding levels for Council to consider. After review, the Council provided Developer and staff direction to revise the plan to meet a new not-to-exceed total project budget of \$65 million (\$55M contribution from the City and \$10M contribution from the Developer) and place program elements in such a way that allows for future expansion, and

WHEREAS, A final conceptual plan reflects a party's intent regarding a facility that outlines programmatic elements that are further refined during the development of construction documents in order to comply with local, state and federal building, health and safety codes and operational needs, and

WHEREAS, Upon Council's approval of a final conceptual plan, staff and Surland will prepare a design, funding and construction management agreement that will clarify roles and responsibilities along with phasing options and project milestones in accordance with the Public Contract Code, and

WHEREAS, Surland presented a final conceptual plan options for the Council to consider on August 18, 2020, and

NOW, THEREFORE, BE IT RESOLVED, That the City Council of the City of Tracy hereby approves the Aquatic Center Final Conceptual Plan with a not-to-exceed amount of \$65 million including contingency and soft costs, and in accordance with this resolution.
