Good evening Mayor and Council members,

Thank you for the opportunity to speak tonight on this agenda item which is very near and dear to my heart. For almost 5 years, I have been advocating for the completion of Legacy Fields. I have complained to anyone who would hear me about the poor conditions of the east baseball fields and the dirt parking lots at Legacy. After the completion of Phase 1D in 2019, the city's total investment in Legacy grew to \$33 million but, unfortunately, this did not include the east fields and the parking lot. After numerous council meetings and until tonight, the Legacy completion was just a "can to be kicked down the road!"

Now with a new council and a new mayor, we can assuredly say that common sense has prevailed and the city will finally finish what they had started. One of the complaints from previous council members regarding the funding to complete Legacy, was the large investment with so little in return. One area I have researched which has yet to be explored in depth by the City, is the use of a completed Legacy to host youth soccer, softball, and baseball tournaments. I sent each of you some background information. I have been told by a marketing consultant who specializes in large athletic complexes, that youth sports competition not only survived the 2008 recession, they thrived. A 64 team tournament held over 3 to 4 days would bring over 2000 individuals into Tracy. Each individual spending between \$50-100 per day not counting lodging? Hotels, restaurants, and shops would all benefit from these tournaments. While I am not advocating that time be taken away from local youth and their access, the opportunity may exist to utilize the complex when otherwise idle. Do you think Hella Pie Pizza, La Villa, or The Golden Eagle would like this idea?

While I see great value in amenities such as an aquatic center and a gym going forward, Legacy is shovel-ready and this portion can be completed in about a year. This is also the time for all Tracy youth groups to join as one voice in advocating for these amenities we all desire. And with a unified voice, we can work with the city council to allocate the Measure V funds to the projects which will benefit the youth, keep them off the streets, and exercise the body as well as the mind.

Quality of life is mentioned as a strategic priority of the council, "To provide an outstanding quality of life by enhancing the City's amenities, business mix and services, and cultivating connections to promote positive change and progress in our community."

With the completion of phase 1E of Legacy, you will definitely be improving the quality of life for the thousands of kids who use Legacy, their parents, as well as adult softball and soccer players. You can also take solace in knowing that you have finally completed what other councils before you could not. I look forward to finally see my son Thomas play on a better baseball field than the one I played on, 55 years ago, which until now, has not been the case.

# Grand jury spotlights Tracy council's pattern of hostility, misconduct

Press staff report Jun 6, 2019

The Tracy City Council suffers from hostility between council members and has been unable to agree on an ethics policy that could regulate the behavior of the city's leading elected officials, according to the latest report by the San Joaquin County Civil Grand Jury.

The 2018-19 grand jury report, released Thursday morning, is the result of an investigation that arose from multiple complaints against City Council members, including allegations of conflicts of interest, persistent violations of the council-manager form of government, abuse of power, unexplained executive staff firings and forced resignations, and inability to conduct the public's business in a professional, respectful manner.

The report lists the grand jury's findings and makes recommendations of how the council members can improve their conduct and solve problems outlined by the grand jury.

Members of the Council,

Organized Swimming in Tracy is on life support right now.

As President of the Tracy Tritons, I along with the other members of the Board have tirelessly working to ensure we have a team this Summer, but it has been incredibly difficult. As a result of COVID-19 the school district has shut off rentals to their facilities for the foreseeable future, and have no estimated timeline to allow rentals. Because of the closure of the school district facilities to third-parties, the year round swim team has moved to Manteca, leaving the Tritons as the only swim program in the City.

Fortunately, the Tritons were able to secure swim space at the public pool for April and May, however once the Cities Summer programs begin in June, the ability to use the ONLY public pool no longer becomes an option and the Tritons must rely on reduced restrictions and reopening of the school district facilities in order to continue. Because the lack of facilities in Tracy, if the school district does not allow rentals, the Tritons have a very high likelihood of having no place to practice and therefore would be forced to close, issue refunds to all our families and assess the viability of the program which has been a staple of the community since 1965.

We must as a community stop the petty squabbling over priorities and endless reassessments and focus on what counts, building community. There are a number of needs necessary to build community for Tracy, and that acknowledgement by the members of the community is why Measure V passed.

I grew up swimming for the Tracy Tritons, I want my children to have that opportunity in Tracy as well.

I am speaking to you tonight as a representative of Tracy Babe Ruth to voice my concerns specifically regarding the Legacy Fields complex located at 4901 N Tracy Blvd. After working closely with City Staff on the 2021 field allocation it became apparent to me that our city has very limited real-estate for our youth to play baseball, softball, basketball, football, soccer and swimming. Furthermore, the sharing of Legacy fields has only strengthened Tracy Babe Ruth and Tracy Little League and has united these two organizations with the same vision to see Legacy Fields completed.

I realize it is easy for me to sit here and voice my concerns without providing you with some context behind my thoughts. I would much rather provide you my solutions to consider.

As you discuss Measure V this evening it is my understanding that the funding of a water theme park on the South side of town is one of the primary discussions. Additionally, I understand that the price tag is in the neighborhood of \$65 million. My concern as a Tracy resident is that we often chase the shiny object that is most attractant and seem to forget about the projects that have been started and are not completed, specifically Legacy Fields. However, I do think there can be a happy medium to address all of the projects we have ongoing in Tracy. In fact, may I suggest a phased approach to your proposed water theme park? Have you considered building the infrastructure and a pool to start? Utilizing this method of a phased approach could be implemented to complete Legacy Field.

My suggestion would be for the council to consider a finishing phased 1 approach for the completion of Legacy Field. My suggested approach is to complete the already engineered East diamonds to look like the West diamonds. This includes stadiums lighting for the fields.

To keep costs in perspective, the city council has already agreed and spent millions of dollars on the design phase of Legacy Fields. In fact, both Tracy Little League and Tracy Babe Ruth have worked closely with city staff by providing feedback on implementation and design. That design was paid for, and the remainder of the East fields are shovel ready and if started this summer/fall would be playable in the fall of 2022. Conversely, by pushing off the completion of Legacy Field East it could cause future design costs. Re-design may be caused by building code changes in the future that none of us could predict.

Since the late 1980's, the vision was to a build a sports center all inclusive, that was the focus of city council. Decades later, Legacy Fields was born but has yet to be completed. The vision for all youth sports, including an gymnasium to be built in one location created by previous councils and was the dream for many families across Tracy.

As I think about the future of Legacy Fields, I think about revenue coming into the City of Tracy. As a representative of Tracy Babe Ruth, I think about the thousands of families that would flock to Tracy to play regular season games as well as post season tournaments. This activity brings players from surrounding San Joaquin County, and all contributing to local revenues.

This request is not about Tracy Babe Ruth! It is about our youth players in our community. The completion of Legacy Field East brings additional usage and revenues through Travel ball tournaments as well as additional fields for our Junior Giants program. This allows more playing time tor baseball/softball teams, and hopes of the new basketball facility. It is a sports tourist destination for outside travel ball organizations due to the location and easy access to our city.

In closing, I ask you to consider where your project funding will be allocated and not just focus on one specific project. Consider parsing out funding on several projects utilizing a phased approach so all families in our community could benefit. You made an outstanding investment in Legacy Fields and I am sure you would like to see that project come to a close!

Tracy City Council,

I am speaking to you tonight as a representative of Little League Baseball to voice my concerns specifically regarding the Legacy Fields complex located at 4901 N Tracy Blvd. After working closely with City Staff on the 2021 field allocation it became apparent to me that our city has very limited real-estate for our youth to play baseball, softball, basketball, football and swimming. Furthermore, the sharing of Legacy fields has only strengthened Tracy Babe Ruth and Tracy Little League and has united these two organizations with the same vision to see Legacy Fields completed.

I reflect back to the groundbreaking ceremony in 2012 when Tracy Little League engaged in a private public partnership to give our youth a place to call home. The sweat equity and hard work from all of our, purely volunteer organization raised nearly \$200K to contribute towards a field that was playable. The P3 agreement for Tracy Little League, at that time was a strain on our nonprofit status and provided little internal revenues to apply towards the build.

I realize it is easy for me to sit here and voice my concerns without providing you with some context behind my thoughts. I would much rather provide you my solutions to consider.

As you discuss Measure V this evening it is my understanding that the funding of a water theme park on the South side of town is one of the primary discussions. Additionally, I understand that the price tag is in the neighborhood of \$60MM. My concern as a Tracy resident is that we often chase the shiny object that is most attractant and seem to forget about the projects that have been started and are not completed, specifically Legacy Fields. However, I do think there can be a happy medium to address all of the projects we have ongoing in Tracy. In fact, may I suggest a phased approach to your proposed water theme park? Have you considered building the infrastructure and a pool to start? Utilizing this method of a phased approach could be implemented to complete Legacy Field.

It reliefs the existing fields we lease in the City of Tracy allowing more playing space for the ever-growing amount of baseball/softball teams. It is a sports tourist destination for outside travel ball organizations due to the location and easy access to our city.

You can imagine what COVID-19 has done to all youth sports programs for 2020. Although, players may not be on the field we anticipate our 2021 season to grow 25+%. These kids are ready to get back to organized sports! If the plan to move forward on Legacy Field East is considered there will be minimal impact to the operations leaving our trade workers, the room they need to get the work completed.

In closing, I ask you to consider where your project funding will be allocated and not just focus on one specific project. Consider parsing out funding on several projects utilizing a phased approach so all families in our community could benefit. You made an outstanding investment in Legacy Fields and I am sure you would like to see that project come to a close!
